





Tertiary Education (Fees) Regulations 2004

Notice is given that in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Tertiary Education (Fees) Regulations 2004.

The reason for the proposed regulations is to replace the Tertiary Education (Fees) Regulations 1993. These regulations are due to sunset on 28 June 2004, however the reasons for introducing the new regulations now are outlined in the RIS.

The RIS explains the regulatory environment of the higher education sector, the proposed new fee structure, the basis upon which the fee levels are set, whether other practicable means are available to partially recover costs associated with the assessment of applications, an assessment of the costs and benefits of the regulations and a comparison with fees in other Australian states.

The objectives of the proposed regulations are to prescribe fees for the purposes of the **Tertiary Education Act 1993** as follows —

Endorsement of courses of study for overseas students

The objective of this regulation is to set a fee for the assessment of an application from a self-accrediting higher education provider and from a non self-accrediting higher education provider for the endorsement of a course of study for the enrolment of students from overseas.

Accreditation of higher education courses of study

The objective of this regulation is to set a fee for the assessment of an application from a non self-accrediting provider for the accreditation of a course of study as a higher education course.

Authorisation to conduct higher education courses of study

The objective of this regulation is to set a fee for the assessment of an application from a non self-accrediting provider for authorisation to conduct an accredited higher education course of study.

Approval to operate as a university

The objective of this regulation is to set a fee for the assessment of an application from an institution for approval to operate as a university.

The RIS discusses possible alternatives to making the regulations and concludes that there are no other practicable alternatives. The RIS concludes that there is only a small impact on applicants and an even smaller impact on students of providers. The RIS also concludes that the regulations do not restrict competition.



Control of Weapons Act 1990

ORDER IN COUNCIL

1. The Governor in Council, pursuant to section 8B of the Control of Weapons Act 1990, grants an exemption from the operation of section 5(1) of the Control of Weapons Act 1990 to the following classes of persons:

Authorised employees	Bringing into Victoria, causing to be brought or sent into Victoria, purchasing or possessing oleoresin capsicum spray in the course of their official duties.
Authorised Fisheries Officers	Bringing into Victoria, causing to be brought or sent into Victoria, purchasing, possessing or using oleoresin capsicum spray in the course of their official duties.
Authorised Wildlife Officers	Bringing into Victoria, causing to be brought or sent into Victoria, purchasing, possessing or using oleoresin capsicum spray in the course of their official duties.

- 2. For the purposes of this Order:
 - (a) "Authorised Fisheries Officers" means those persons appointed as authorised officers under section 83 of the Conservation, Forests and Lands Act 1987 and whose official duties involve the enforcement of the provisions of the Fisheries Act 1995 and the Wildlife Act 1975.
 - (b) "Authorised Wildlife Officers" means those persons appointed as authorised officers under section 83 of the Conservation, Forests and Lands Act 1987 and whose official duties involve the enforcement of the provisions of the Fisheries Act 1995 and the Wildlife Act 1975.
 - (c) "Authorised employee" means an employee of the Department of Primary Industries or the Department of Sustainability and Environment authorised by the relevant Secretary of those Departments to purchase, store, possess and distribute equipment to Authorised Fisheries Officers and/or Authorised Wildlife Officers.
- 3. Under section 8B of the Control of Weapons Act 1990, this exemption only applies to:
 - (1) Authorised Fisheries Officers who:
 - (a) are not prohibited persons under the **Control of Weapons Act 1990**;
 - (b) have successfully completed the training requirements set out in the training manual issued from time to time by the Secretary of the Department of Primary Industries and approved by the Chief Commissioner of Police or his/her delegate, in relation to oleoresin capsicum spray;
 - (c) comply at all times with the instructions set out in the policy and operating procedures issued by the Secretary of the Department of Primary Industries and endorsed by the Minister for Police and Emergency Services in relation to the issue, carriage, use and storage of oleoresin capsicum spray; and
 - (2) Authorised Wildlife Officers who:
 - (a) are not prohibited persons under the Control of Weapons Act 1990;

- (b) have successfully completed the training requirements set out in the training manual issued from time to time by the Secretary of the Department of Sustainability and the Environment and approved by the Chief Commissioner of Police or his/her delegate, in relation to oleoresin capsicum spray;
- (c) comply at all times with the instructions set out in the policy and operating procedures issued by the Secretary of the Department of Sustainability and the Environment and endorsed by the Minister for Police and Emergency Services in relation to the issue, carriage, use and storage of oleoresin capsicum spray.
- 4. The Order made on 24 June 2003 pursuant to section 8B of the Control of Weapons Act 1990 and applicable to Authorised Fisheries Officers is hereby revoked.
- 5. This Order comes into operation on the date that it is made.
