### Notice of Approval of Amendment Amendment VC24

The Minister for Planning has approved Amendment VC24 to the Victoria Planning Provisions.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- Introduces a new Farming Zone and a new Rural Activity Zone in the Victoria Planning Provisions;
- Amends Clause 17.05 (Agriculture) in the State Planning Policy Framework in the Victoria Planning Provisions and all planning schemes except the Port of Melbourne Planning Scheme;
