NOTICE OF DECISION

Prevention of Cruelty to Animals (Amendment) Regulations 2004

I, Bob Cameron, Minister for Agriculture and Minister responsible for administering the Prevention of Cruelty to Animals Act 1986, give notice under section 12 of the Subordinate Legislation Act 1994 as follows:

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Prevention of Cruelty to Animals (Amendment) Regulations 2004. The RIS was advertised to invite public comment. 124 submissions were received and have been considered.

I have decided that the proposed Regulations should be made with the following amendments:

- the commencement date for the regulations will be the day after the day on which the Regulations are made;
- proposed regulations 8 (Scientific establishment returns), 11 (Application for the issue or renewal of a scientific establishment licence), 12 (Scientific Establishment Licence) and 13 (Substitution of a new Schedule 8) are omitted as the amendments to be effected by these regulations will be incorporated in a more comprehensive review of provisions regulating scientific establishments using animals in scientific procedures.
