## Water Industry Act 1994

### MELBOURNE METROPOLITAN WATER, WASTEWATER AND DRAINAGE SERVICES PRICING ORDER

#### Amending Order in Council

The Governor in Council amends the Melbourne Metropolitan Water, Wastewater and Drainage Services Pricing Order 2001 made by Order in Council on 27 June 2001 and published in Government Gazette G26 on 28 June 2001 under section 21A of the **Water Industry Act 1994**, and amended by Order in Council on 3 April 2002 and published in Government Gazette G14 on 4 April 2002 as follows:

- (a) Under the heading “1.4 Term of Order”, delete “30 June 2004” and insert “30 June 2005”; and
- (b) In Schedule 2, insert columns headed “Financial Year 2004-05” providing a formula for setting charges for the financial year 2004-05 as follows:
