NOTICE UNDER SECTION 158BA(1A)

I, John Brumby, the Minister administering the **Electricity Industry (Residual Provisions) Act 1993**, pursuant to the authorisation of the Governor in Council by Order dated 29 June 2004, specify that with effect from 1 July 2004:

1. the Smelter Reduction Amount Rate (1) for the purposes of clause 3.3 of schedule 9A.2 of the National Electricity Code will be zero; and
2. the Smelter Reduction Amount Rate (2) for the purposes of clause 4.3 of Schedule 9A.2 of the National Electricity Code will be zero.
