### NOTICE OF MAKING OF ORDER UNDER SECTION 13 AND ADMINISTRATIVE ARRANGEMENTS ORDER (NO. 180) 2002

An Order of the Minister for Education Services was made on 2 June 2004 under section 13(4) of the **Education Act 1958** and Administrative Arrangements Order (No. 180) 2002 amending the constituting Order (the Order) of the school council of the State school proposed to be called Benton Junior College (the Council) by inserting a new Part D into the Order to-

1. appoint eleven persons (including the Principal as ex officio member) to the Council for the terms of office stated,
2. provide for a school council election to be completed by 30 June 2004,
