





All hospitals and health services to whom this policy applies ("Applicable Hospitals") are required to abide by the outcomes of the planned HPV Tenders listed in the 2004 – 2006 Timetable, which is a Schedule to this policy.

Applicable Hospitals are required to only purchase goods and or services which will be the subject of those tenders from the successful tenderers with whom HPV enters into a contractual relationship to supply those goods and services.

A hospital or health service is exempt from the specific application of this policy, where it has a current contract in respect of the supply of goods and or services which are named in the Schedule.

Hospitals and health services with such contracts are required not to exercise any option to renew or extend the term of that contract without the prior written consent of HPV. Such hospitals and health services are required to comply with this policy in all other respects.

Hospitals and health services may only enter into a contract with suppliers for goods/services as per the attached tender program if HPV gives its prior written consent or where there is an ability to terminate agreements when the relevant HPV tender is awarded.

This policy is to apply to all public hospitals listed in Schedule 1 of the Act and all metropolitan/public health services listed in Schedule 5 of the Act, unless specifically exempted in accordance with section 134A of the

Hospitals and health services are required to report their compliance with this policy by means of an annual statement of compliance in a form to be advised by HPV.

The obligations contained in this Policy will apply from the date of gazettal of the notice of making of this Policy (July 01 2004), until HPV otherwise declares.



State Owned Enterprises Act 1992

STATE OWNED ENTERPRISES (STATE BODY – VICTORIAN COMPETITION AND EFFICIENCY COMMISSION) ORDER 2003

Order in Council

The Governor in Council, acting under section 14 of the **State Owned Enterprises Act 1992**, makes the following Order:

1. Commencement

This Order comes into operation on 1 July 2004 or the day on which this Order is published in the Government Gazette, whichever is the later.

2. Definitions

In this Order-

"Act" means the State Owned Enterprises Act 1992;

"business impact assessment" means an analysis of proposed legislation with a potentially significant impact, in accordance with guidelines and policies currently applying to the Victoria Government: and

"Commission" means the Victorian Competition and Efficiency Commission;

"regulatory impact statement" has the same meaning as in section 10 of the Subordinate Legislation Act 1994

"Treasurer" means the Minister who has the responsibility for Division 2 Part 2 of the State Owned Enterprises Act 1992 in so far as that Division relates to the Commission.

3. The Victorian Competition and Efficiency Commission

- (1) There is established for the purposes of the Act, a State body by the name of the Victorian Competition and Efficiency Commission.
- (2) The particular purpose of establishing the Commission is to maintain and improve competition and efficiency in the Victorian economy.
- (3) The functions of the Commission are to:
 - (a) for the purposes of section 10(2) of the **Subordinate Legislation Act 1994**, independent advice as to the adequacy of regulatory impact statements and of assessments of the costs and benefits of proposed statutory rules and of any other practicable means of achieving the same objectives contained within the regulatory impact statements;
 - (b) provide independent advice as to adequacy of any business impact statements in accordance with any requirements issued by the Minister, with the approval of the Premier, from time to time;
 - (c) undertake inquiries into any matter referred to it by the Treasurer;
 - (d) achieve awareness of and compliance with the competitive neutrality policy of the Victorian Government currently in force.
- (4) The Commission has the power to do everything necessary or convenient to be done for, or in conjunction with, the performance of its functions other than the power to employ staff. The Commission will be supported by a Secretariat located within the Department of Treasury and Finance.
- (5) The Commission must be as efficient as possible in pursuing its undertakings and must act in accordance with the principles:
 - (a) the provision of analysis and advice that is independent and rigorous;
 - (b) an overarching concern for the well-being of the community as a whole, rather than the interests of particular industries or groups.
- (6) The Commission must operate in a framework consistent with Victorian Government's social, economic and environmental policies and priorities.
- (7) The Commission must, in addition to any reporting requirements under the **Financial Management Act 1994**, report annually to the Treasurer on:
 - (a) its performance against its annual work program;
 - (b) developments in regulation and their enforcement within Victoria;
 - (c) the nature and extent of compliance with published policies currently applying to government bodies in relation to regulatory impact statement and business impact assessments;
 - (d) the number of complaints received about the competitive neutrality of government business and business activity, and the outcomes of the investigation into those complaints; and
 - (e) the content and action taken in respect of any direction made by the Treasurer to the Commission under the Act.
- (8) The Treasurer should publicly release the Commission's annual report within three months of receiving it from the Commission.

4. Inquiries

- (1) The Commission must conduct an inquiry into any matter that the Treasurer by written notice refers to the Commission.
- (2) The Treasurer may:
 - (a) require the Commission to hold hearings for the purpose of an inquiry;

- (b) specify a period within which the Commission must submit its written report on the inquiry to the Treasurer;
- (c) require the Commission to make a draft report available to the public during an inquiry; and
- (d) require the Commission to report with or without recommendations in relation to the matter.
- (3) The Treasurer may withdraw or amend a reference at any time before receiving the final report.
- (4) The Commission must report in accordance with sub-clause (2) unless the Treasurer withdraws the reference prior to the completion of the final report.
- (5) The Treasurer should publicly release the final report within six months of receiving it from the Commission.
- (6) The Government should publicly release a response to the final report within six months of the Treasurer receiving that final report from the Commission, regardless of the date of release of the final report by the Treasurer.
- (7) Before the Commission begins to hold hearings for the purposes of an inquiry, it must give reasonable notice, by advertisement published in a newspaper circulating within the State, of its intention to hold the hearings, the subject of the hearings and the time and place at which the first of the hearings is to begin.
- (8) All hearings, transcripts of hearings and written submissions made to the Commission in respect of an inquiry must be held in or made public except in the circumstances set out in sub-clause (9).
- (9) If the Commission is satisfied that it is not in the public interest to—
 - (a) hold hearings in public, or
 - (b) make public some or all of the transcripts of hearings or of written submissions made to the Commission—

because of the confidential nature of the evidence or matter, or for any other reason, it may-

- (c) direct that the hearing, or that part of it, take place in private;
- (d) withhold publication of transcripts of hearings and written submissions (in whole or in part); and
- (e) give directions as to who may be present at any relevant hearing.

5. Review of regulatory impact statements and business impact assessments

The Commission will review the quality of business impact assessments and regulatory impact statements having regard to relevant guidelines issued from time to time by the Government, and provide comment on these assessments and statements to the Department of the Minister responsible for the proposed legislation.

6. Competitive neutrality complaints

- (1) The Commission may receive a complaint in writing and in the form required by the Commission that a particular government business or business activity is not being conducted in accordance with the competitive neutrality policy of the Victorian Government currently in force.
- (2) In considering the complaint, the Commission must give particular regard to the interests of the users of the goods and services provided by the particular State or local government business or through the particular State or local government business activity.

- (3) In accordance with the Victorian Government's policy on Competitive Neutrality, the Commission must give particular consideration to the public interest requirements in clause 1 of the Competition Principles Agreement signed by all jurisdictions in 1995 or any subsequent intergovernmental agreement on competitive neutrality.
- (4) The Commission may decide not to investigate a complaint, if in the opinion of the Commission:
 - (a) the complaint is frivolous or vexatious or was not made in good faith; or
 - (b) the complainant does not have sufficient interest in the subject matter of the complaint; or
 - (c) an investigation is not warranted having regard to all the relevant circumstances.
- (5) If the Commission decides not to investigate a complaint it must inform the complainant of that decision.
- (6) The Commission will communicate the outcome of its investigation of a complaint in accordance with Victorian Government's policy on Competitive Neutrality currently in force.

7. Commissioners

- (1) There is a Board of Commissioners of the Commission which-
 - (a) is responsible for managing the affairs of the Commission; and
 - (b) may exercise the powers of the Commission.
- (2) The Commission consists of a Chair (who is a Commissioner for the purposes of this Order) and between two to four additional Commissioners all of whom will have experience as business leaders, academics and/or public policy practitioners.
- (3) A Commissioner will be appointed by the Governor in Council on the terms and conditions of appointment specified in the instrument of appointment.
- (4) A Commissioner shall be appointed for a term of up to three years and is eligible for reappointment.
- (5) A Commissioner may resign by writing delivered to the Governor in Council.
- (6) The Governor in Council may suspend a Commissioner from office.
- (7) The Governor in Council may terminate a Commissioner's appointment for misbehaviour or physical or mental incapacity.
- (8) A Commissioner shall be deemed to have vacated his or her office if the Commissioner-
 - (a) becomes bankrupt;
 - applies to take the benefit of any law for the relief of bankrupt or insolvent debtors;
 or
 - (c) compounds with his or her creditors or makes an assignment of remuneration to them.
- (9) An act or decision of the Board is not invalid by reason only of a defect or irregularity in, or in connexion with, the appointment of a Commissioner, or of a vacancy in the office of the Chair or of a Commissioner.

8. Proceedings of the Board of Directors

- (1) Subject to this clause, the Commission may regulate its own proceedings.
- (2) Meetings of the Commission shall be held at the times and places determined by the Commissioners.
- (3) The Chair may at any time convene a meeting and must do so when requested by a Commissioner.

- (4) A simple majority of the Commissioners appointed for the time being constitutes a quorum of the Commission.
- (5) If the Chair is not present at a meeting of the Board, another Commissioner chosen by the Commissioners then present may preside at the meeting.
- (6) A question arising at a meeting shall be determined by a majority of votes of Commissioners present and voting on that question and, if voting is equal, the person presiding has a casting, as well as a deliberative, vote.
- (7) The Commission must ensure that minutes are kept of each of its meetings.

9. Commissioners' Interests

- (1) Each Commissioner must give written notice to the Treasurer of all direct and indirect pecuniary interests that he or she has or acquires in a business or in a body corporate carrying on a business.
- (2) If any Commissioner has or acquires an interest, pecuniary or otherwise, that could conflict with the proper performance of a function as a Commissioner, he or she must ensure that the interest is disclosed in one of the following ways:
 - (a) if a report or similar document results from the performance of the function in the report or document;
 - (b) in any other case to the person or body for whom the function is being performed.
- (3) A Commissioner is required to notify the Treasurer of any changes to their employment that may affect their ability to properly undertake their duties as a Commissioner.
- (4) Unless the Treasurer or the Commission otherwise determines, where a Commissioner has made a disclosure under sub-clause (1), that Commissioner—
 - (a) must not be present during any deliberation of the Commission in relation to the matter; and
 - (b) must not take part in any decision of the Commission in relation to the matter.
- (5) For the purpose of the making of a determination by the Commission under sub-clause (4) in relation to a Commissioner who has made a disclosure under sub-section (1), a Commissioner who has a direct or indirect pecuniary interest in the matter to which the disclosure relates –
 - (a) must not be present during any deliberation of the Commission for the purpose of making the determination; and
 - (b) must not take part in the making by the Commission of the determination.
- (6) Sub-clause (1) does not apply in relation to a matter relating to the supply of goods or services to the Commission if the goods or services are, or are to be, available to members of the public on the same terms and conditions.

10. Exercise of powers on the Commission's behalf

An executive (as defined in the **Public Sector Management and Employment Act 1998**) employed in the Commission's Secretariat may act in the name and on the behalf of the Commission as determined by the Commission.
