Commonwealth Games Arrangements Act 2001 COMMONWEALTH GAMES PROJECT ORDER

Games Village Supplementary Project

- 1. This declaration is made in accordance with section 15 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), by me as the Minister administering the Act.
- 2. I declare the works to be carried out on "the Games Village Supplementary Land" as defined in the Commonwealth Games Venue Order made on 5 July 2004 to be a Commonwealth Games project to which the Act applies.
- 3. I authorise the development of that project for the period commencing on the date of publication of this Order until its completion.
- 4. In accordance with section 17 of the Act I specify the Secretary, as defined in the Act, to be responsible for the project to which this Order applies.
- 5. In accordance with section 26 of the Act I specify that the Secretary, as defined in the Act, is to be responsible for managing or developing the project.
- 6. This Order shall take effect from the date of its publication in the Government Gazette.


Commonwealth Games Arrangements Act 2001 COMMONWEALTH GAMES VENUE ORDER

Commonwealth Games Village Supplementary Land
