1. Title

This Order may be cited as the Declaration of Transferred Licences (East) Order 2004.

2. Objectives

The objectives of this Order are to declare specified licences or permits granted under section 52 of the **Forests Act 1958** and in existence immediately before the commencement of section 25 of the **Sustainable Forests (Timber) Act 2004** in respect of an area in the east of the State of Victoria to be transferred licences (east).

3. Authorising provision

4. Commencement date

This Order takes effect on 1 August 2004.
