**MELBOURNE PLANNING SCHEME**  
Notice of Approval of Amendment  
Amendment C77

The Minister for Planning has approved Amendment C77 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment changes Schedule 15 to Clause 43.02 – Design and Development Overlay by identifying two areas – Area 1 (DDO15–A1) and Area 2 (DDO15–A2) – and by changing the existing 12m height limit within Area 1 from a discretionary to a mandatory control, with the views of the Director of the Royal Botanic Gardens to be sought only for those applications where the responsible authority considers that the application involves works which may be visible from the Royal Botanic Gardens.

A copy of the Amendment can be inspected, free of charge, during office hours, at the Department of Sustainability and Environment, Planning Information Centre, Upper Plaza, Nauru House, 80 Collins Street, Melbourne and at the offices of the Melbourne City Council, 6th Floor, Council House, 200 Little Collins Street, Melbourne.
