## Fair Trading Act 1999

### PERMANENT BAN ORDER PROHIBITING THE SUPPLY OF DANGEROUS GOODS

I, John Lenders, Minister for Consumer Affairs, pursuant to the powers conferred on me by Part 3 Division 1 of the **Fair Trading Act 1999**, hereby make a permanent ban order (the "Order") prohibiting the supply in Victoria of the following goods:

Objects that are imitation baby's dummies and objects that resemble a baby's dummy (as defined in the Schedule) in appearance and size and which do not comply with the requirements of Australian Standard AS 2432 – 1991.

I make this permanent ban order on the recommendation of Dr David Cousins, Director of Consumer Affairs Victoria, in accordance with section 40(2)(a) of the **Fair Trading Act 1999**.

Baby's dummy means an object used to pacify a baby and the object includes a teat, which the baby sucks but from which the baby does not obtain fluid.

#### Explanatory Note

This permanent ban order prohibits the supply of imitation dummies that may cause persons, in particular children, to confuse them with a baby's dummy and in consequence place them in their mouths and where such action may cause serious injury or death. This order does not apply to goods that comply with the requirements of Australian Standard AS 2432–1991.
