Commonwealth Games Arrangements Act 2001

COMMONWEALTH GAMES VENUE ORDER – AMENDMENT

In accordance with section 19 of the **Commonwealth Games Arrangements Act 2001** (“the Act”) I, as the Minister administering the Act, amend the Commonwealth Games Venue Order dated 30 March 2004 and defined as the whole of the area of the “Yarra Precinct Pedestrian Link” published in the Government Gazette on 31 March 2004, and declare the following area of land to be a Commonwealth Games venue to which the Act applies:

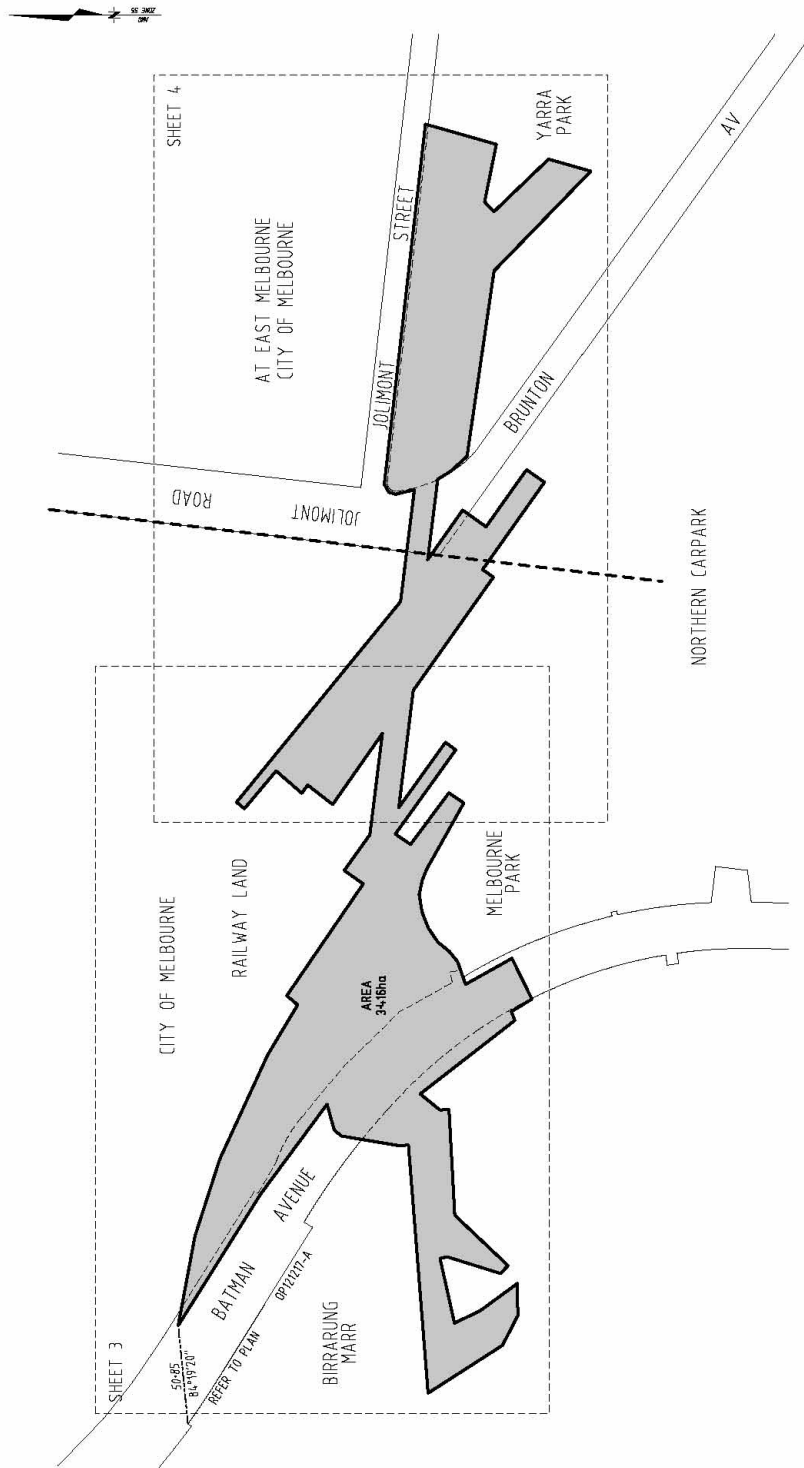

This Order shall take effect from the date of its publication in the Government Gazette.

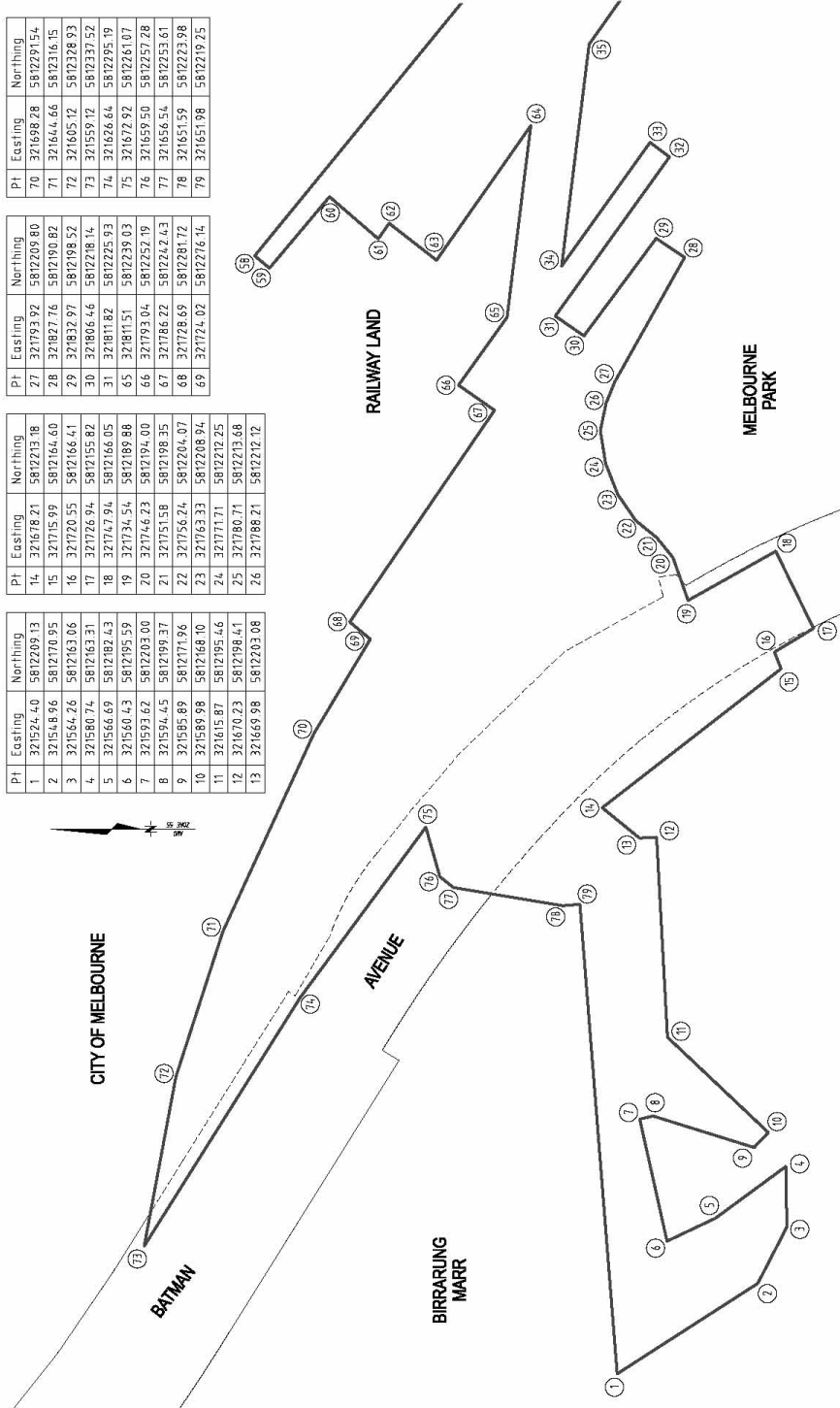

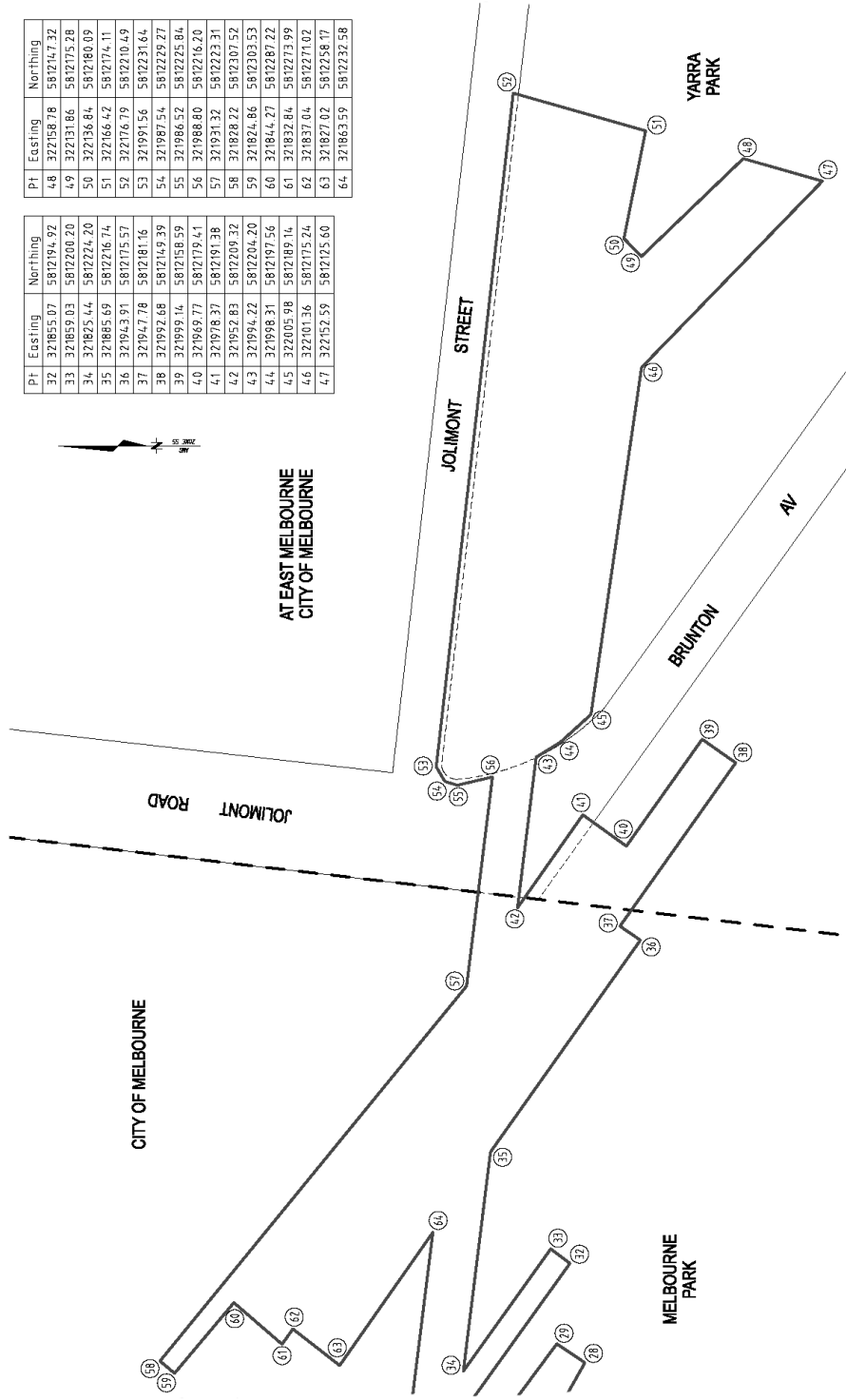

DESIGNATED ACCESS AREA ORDER

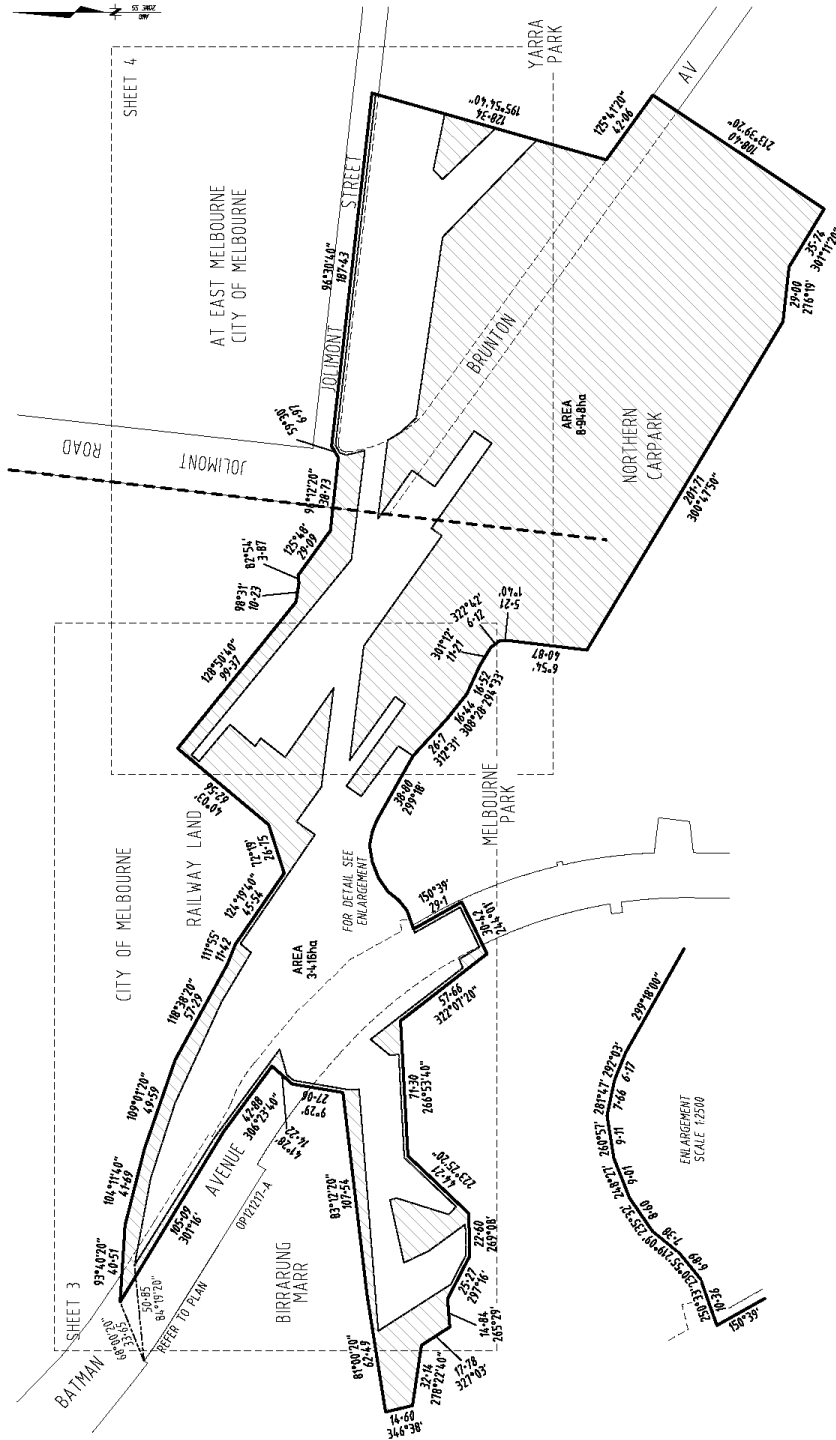
In accordance with section 16 of the **Commonwealth Games Arrangements Act 2001** (“the Act”) I, as the Minister administering the Act, declare the following area of land adjacent to the Commonwealth Games venue (Yarra Precinct Pedestrian Link) to be a designated access area, being:

all of the land shown cross-hatched on the attached plan numbered LEGL./04-475 sheet 1 of 4 and adjacent to the Commonwealth Games Venue “Yarra Precinct Pedestrian Link” shown hatched on plan numbered LEGL./04-475 sheets 2,3 & 4 of 4 for the period commencing 14 September 2004 and ending at 31 March 2006.

This Order shall take effect from the date of its publication in the Government Gazette.
