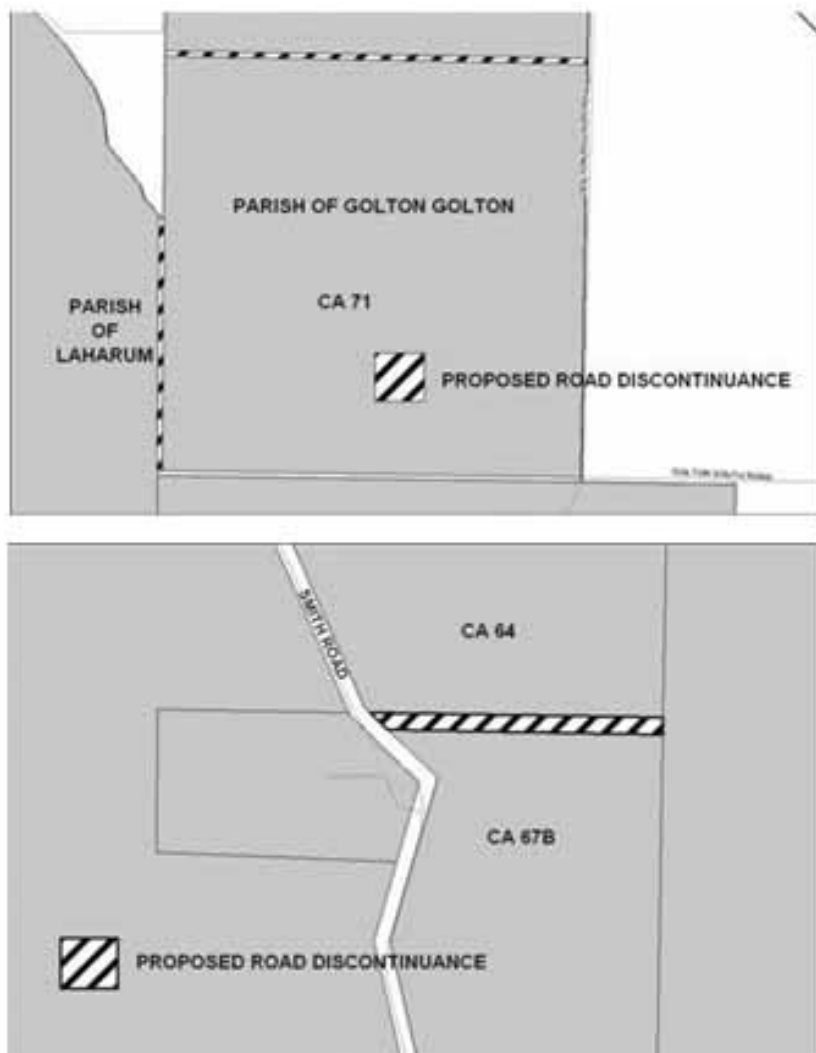

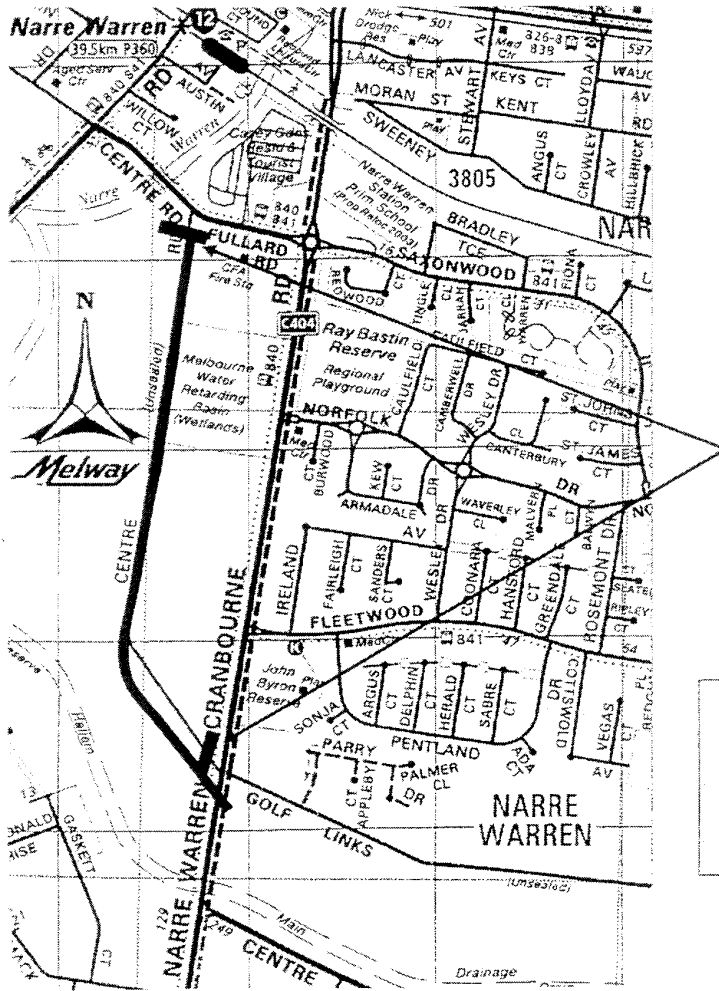

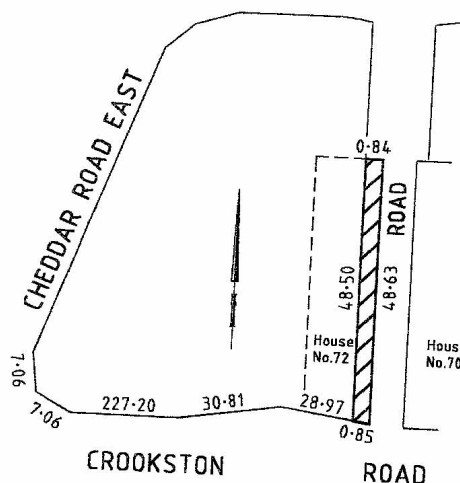

The Department of Sustainability and Environment is in the process of reviewing the Code of Practice for Fire Management on Public Land and is looking for community involvement. The existing "Code" was written in 1995, under the **Conservation, Forests and Lands Act 1987**, and is now due for review.

The "Code" provides the overall framework for the integrated management of fire and fire related activities on public land in Victoria. It ensures that the response to wildfire and the use of prescribed burning are in accordance with sound environmental guidelines, and assists the achievement of other management objectives.

Formal comment from the community will be sought at two key stages, at the release of a discussion paper in February 2005 and again when a draft "Code" is released in May 2005. Details of how to obtain a copy of these documents will be advertised in major metropolitan and regional Victorian newspapers.
