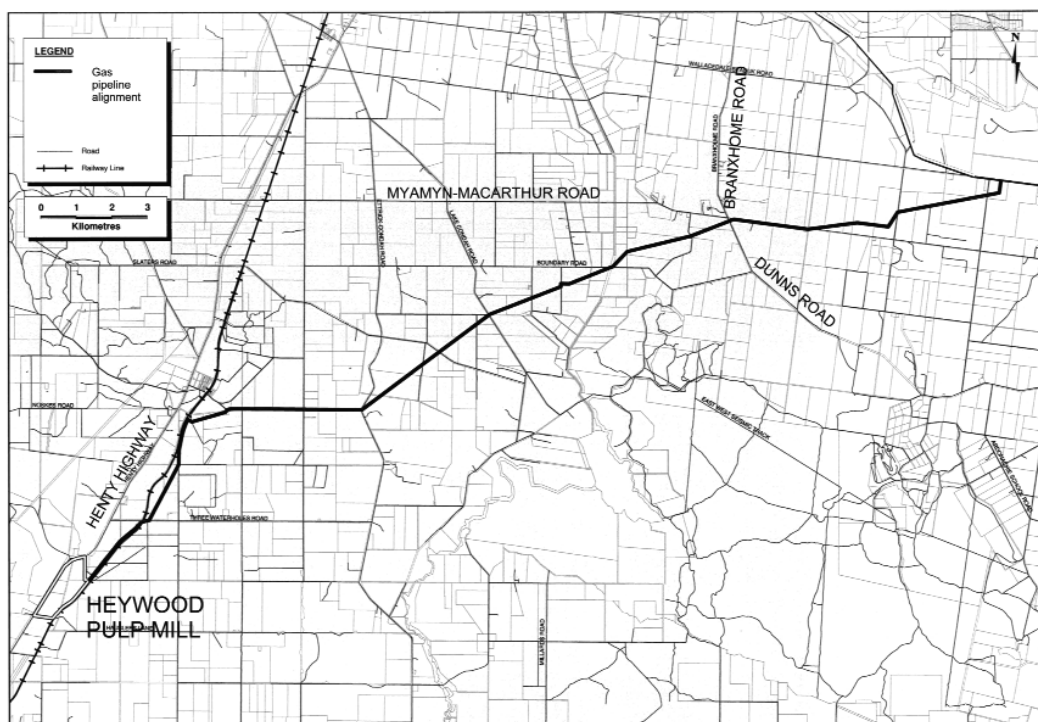

NOTICE UNDER SECTION 11 OF THE PIPELINES ACT 1967 (VIC)

Application for a Permit to Own and Use Pipeline 260

1. In accordance with the provisions of Section 11 of the **Pipelines Act 1967** (Vic), notice is given that an application has been received from Heywood Pulp Pty Ltd (ABN 39 008 488 373) (the applicant) for a Permit to Own and Use a Pipeline for the purpose of conveying natural gas from the SEA Gas pipeline 4km south of Byaduk to the Heywood Pulp Mill.
2. An Environment Effects Statement (EES) has been prepared for the project. The exhibition of the EES was also notified by the applicant in The Age and The Hamilton Spectator on 15 November 2005 and in The Portland Observer on 16 November 2005 under the provisions of the **Environment Effects Act 1978** (Vic). Copies of the EES may be inspected at the same locations as the plans of the proposed route of the pipeline. Please refer to point 4 of this Notice for a list of locations.
3. The proposed route of the pipeline is described and shown on the map below:



The permit relates to a steel pipeline approximately 31kms in length with a nominal bore of 200 millimetres (subject to design), commencing at the SEA Gas pipeline (Pipeline Licence 239) 4km south of Byaduk at the junction of Dairy Hills Road and Stewarts Road and terminating at the Heywood Pulp Mill 5km north-east of Heywood.

4. The above plan is only indicative and detailed plans of the proposed route of the pipeline may be inspected between the hours of 9:00 am and 4:00 pm Mondays to Fridays (excluding
