## Transport Accident Act 1986

TRANSPORT ACCIDENT CHARGES ORDER (NO. 2) 2005

### ERRATUM

In the Order-in-Council made under section 110(8) of the **Transport Accident Act 1986** on 22 November 2005 and published in the Government Gazette G47 on 24 November 2005 (pages 2755 -2761) the numbering of the descriptions of vehicle Class in Item 1 of Schedule 1 was published incorrectly.

The description of vehicle Class in Item 1 appeared in the Government Gazette on page 2758 as follows:

#### 1. Passenger Vehicles

- a) Any motor vehicle with sedan, station wagon or related body-type (including 4WD passenger vehicle) not included in any other class; self-propelled caravan; ambulance; hearse; mourning coach; private hire car licensed under the **Transport Act 1983**
- a) Any motor vehicle with a bus or forward-control body-type constructed and primarily used for carrying passengers, but not for hire, fare or reward
  - i) Seating fewer than 10 people (including the driver)
  - ii) Seating more than 9 people (including the driver)
- b) Taxi licensed under the **Transport Act 1983**
- c) Bus any motor vehicle, other than a taxi cab or private hire car, licensed for or primarily used for carrying passengers for hire, fare or reward
  - i) seating fewer than 10 people (including the driver)
  - ii) seating more than 9 but fewer than 31 people (including the driver), the relevant zone charge for a bus under (i), plus for each additional seat over 9

iii) seating 31 people or more
