## Country Fire Authority Act 1958

### DECLARATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by Section 4 of the **Country Fire Authority Act 1958**, I, Neil G. Bibby, Chief Executive Officer of the Country Fire Authority, after consultation with the Secretary to the Department of Sustainability and Environment, hereby declare the following periods to be the Fire Danger Period in the municipal districts of the municipalities or parts of municipalities specified, commencing on the dates shown, and unless varied by subsequent declaration, ending at 0100 hours on 1 May 2006.

To commence from 0100 hours on 28 November 2005:

Shire of Yarriambiack;

Rural City of Swan Hill;

Shire of Buloke (northern part) – That part north of the Beulah–Birchip, Birchip–Wycheproof, Boort–Wycheproof arterial roads, excluding the road reserve and the urban townships of Birchip and Wycheproof;

Shire of Hindmarsh (northern part) – That part north of the wire netting fence;

Rural City of Horsham (northern part) – That part north of the line described by the following roads: Bow Lake Fire Access Road, Bow Lake Road, Jallumba/Clear Lake Road, Jallumba/Mockinya Road, Wonwondah/Toolondo Road, North East Wonwondah Road, Grampians Road, Wonwondah/Dadswells Bridge Road, Fullbrooks Road to the Wilmmera River.
