Mitcham-Frankston Project Act 2004

ORDER UNDER SECTION 7 VARYING THE PROJECT AREA

Order in Council

The Lieutenant-Governor as the Governor's deputy with the advice of the Executive Council, under section 7(1) of the **Mitcham-Frankston Project Act 2004** ("the Act"), on the recommendation of the Minister for Transport and the recommendation of the Minister for Planning, given in accordance with section 7(4) of the Act, varies the Project area, as defined in section 5 of the Act, by making the following changes to the Project area as shown on the relevant LEGL plans identified below and lodged at the Central Plan Office of the Department of Sustainability and Environment:

- a) adding the land shown as shaded on the plan numbered LEGL./05-271 and more particularly described by reference to parcels numbered 204 and 205 on survey plan numbered SP 17934A;
- b) adding the land in stratum below 10 metres below natural surface level which is shown as stippled but not hatched on the plans numbered LEGL./05-272 and LEGL./05-273;
- c) adding the land in stratum shown as circle-hatched (including where simultaneously shown as shaded) on the plans numbered LEGL./05-272 and LEGL./05-273, to the extent that the land shown as circle-hatched is defined in stratum by survey plans numbered SP 20025A, SP 20026A, SP 20027A, SP 20028A, SP 20029A, SP 20030A and SP 20031A, more particularly identified on the LEGL plans by reference to parcel numbers 4, 53 and 72;
- d) excising the land shown as hatched (including where simultaneously shown as shaded) on the plans numbered LEGL./05-273 and LEGL./05-274, except to the extent that:
 - i) the land is defined in stratum on survey plans numbered SP 20025A, SP 20026A, SP 20027A, SP 20028A, SP 20029A, SP 20030A and SP 20031A, the boundaries of the land shown as hatched (including where simultaneously shown as shaded) being more particularly described on the LEGL plans by reference to parcel numbers 120 to 123 (inclusive), 125, 142, 143 and 160 to 164 (inclusive); and
 - ii) the land is defined in stratum on survey plans numbered SP 20889, SP 20890, 20891 and 20892, the boundaries of the land shown as hatched (and simultaneously shown as shaded) being more particularly described on the LEGL plans by reference to part parcel numbers 143A and 160A to 164A (inclusive);
- e) adding the land in stratum shown as brick-hatched (including where simultaneously shown as shaded) on the plans numbered LEGL./05-272 to LEGL./05-274 (inclusive) but only to the extent that the land shown as brick-hatched is defined in stratum by parcel number identified on survey plans numbered SP 20025A, SP 20026A, SP 20027A, SP 20028A, SP 20029A, SP 20030A and SP 20031A; and
- f) excising the land shown as shaded and hatched on the plan numbered LEGL./05-286, the boundaries of the land shown as shaded and hatched being more particularly described on that plan by reference to parcel number 621 and defined by survey plan numbered SP 20272C.

Order in Council

The Lieutenant-Governor as the Governor's deputy, with the advice of the Executive Council, under section 7(2) of the **Mitcham-Frankston Project Act 2004** ("the Act"), on the recommendation of the Minister for Transport and the recommendation of the Minister for Planning, given in accordance with section 7(4) of the Act, varies the Extended Project area, as defined in section 6 of the Act, by making the following changes to the Extended Project area as shown on the relevant LEGL plans identified below and lodged at the Central Plan Office of the Department of Sustainability and Environment:

- a) adding the land shown as shaded on the plan numbered LEGL./05-271 and more particularly described by reference to parcels numbered 204 and 205 on survey plan numbered SP 17934A;
- b) adding the land shown as cross-hatched on the plans numbered LEGL./05-276, LEGL./05-277, LEGL./05-279, LEGL./05-283 to LEGL./05-285, LEGL./05-287 to LEGL./05-291 and LEGL./05-293 (all inclusive), the boundaries of the land being more particularly described on those plans by reference to parcels of land identified by number and defined by survey plans identified as "SP" with numbers following;
- c) adding the land in stratum below 10 metres below natural surface level which is shown as stippled but not hatched on the plans numbered LEGL./05-272 and LEGL./05-273;
- d) excising the land shown as circle-hatched (including where simultaneously shown as shaded) on the plans numbered LEGL./05-272 and LEGL./05-273, except to the extent that:
 - i) the land shown as circle-hatched (including where simultaneously shown as shaded) is defined in stratum on survey plans numbered SP 20025A, SP 20026A, SP 20027A, SP 20028A, SP 20029A, SP 20030A and SP 20031A, the land being more particularly described on those plans by reference to parcel numbers 4, 53 and 72; and
 - ii) the land, shown as circle-hatched and simultaneously shown as shaded, is defined in stratum on survey plan numbered SP 20890, more particularly described on the LEGL plan numbered LEGL./05-273 by reference to part parcel number 53A;
- e) adding the land in stratum shown as shaded (but not circle-hatched) on the plans numbered LEGL./05-272 to LEGL./05-274 (inclusive), the boundaries of the land shown as shaded (but not circle-hatched) being more particularly described on those plans by reference to part parcel numbers 5A to 13A, 17A to 20A, 36A, 40A to 49A, 51A, 52A, 143A to 147A and 160A to 164A (all inclusive) and defined by survey plans numbered SP 20889, SP 20890, SP 20891 and SP 20892; and
- f) excising the land shown as stippled and hatched on the plans numbered LEGL./05-271 to LEGL./05-276, LEGL./05-278 to LEGL./05-282 and LEGL./05-292 (all inclusive), the boundaries of the land shown as stippled and hatched being more particularly described on those plans by reference to parcels of land identified by number and defined by survey plans identified as "SP" with numbers following.
