Marine Act 1988

SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that:

- (1) Bathing and the operation of vessels is prohibited on the waters of Victoria Harbour within the area detailed in Table 1 at the times as specified in Table 2 excluding those persons and vessels detailed below, vessels owned and operated by Parks Victoria and vessels and person involved with the events.
- (2) Bathing and the operation of vessels is prohibited within 75 metres of the fireworks barge located approximately 85 metres west of Central Pier excluding vessels specified in clause 3 below, vessels associated with the fireworks display and vessels owned and operated by Parks Victoria.
- (3) The vessels involved with the Yamaha Tribe Gathering are excluded from Clauses 2(a), 4(b) – when in transit to or from the back of house pontoon, 7(1), 9(1), 14 and 19 (b) of Notice No.1 made under s.15(2) of the Marine Act 1988 for the times detailed in Table 2. These exemptions will apply to operators Jack Ellison, Deon Ellison, Richard Terrill, Peter Chamberlain, Michelle Ellison and Stephen Robinson whilst operating vessels PK 569Q, BO353, 56342, JB676, PK 567Q, PK568Q, PK574Q, JT692, and BO382.
- (4) At the completion of the event specified above, and as determined and announced by the Parks Victoria Ranger in Charge - Yarra River, the waters will revert to the provisions of Schedule 3 contained in Notice No.1 made under subsection 15(2) of the **Marine Act 1988**.

Table 1: Victoria Harbour Exclusion Zone

The waters bounded by:

- (a) A line extending from a red buoy located in approximate position 37° 48.960' S 144° 56.460' E to a red buoy located in approximate position 37°48.990' S 144° 56.460' E;
- (b) A line extending from a red buoy located in approximate position 37°48.990' S 144° 56.460' E to a red buoy in approximate position 37° 49.056' S 144° 56.400' E;
- (c) A line extending from a red buoy located in approximate position 37°49.056' S 144° 56.400' E to a red buoy in approximate position 37° 49.062' S 144° 56.340' E;
- (d) A line extending from a red buoy located in approximate position 37°49.062' S 144° 56.340' E to a red buoy in approximate position 37° 49.002' S 144° 56.340' E;
- (e) A line extending from a red buoy located in approximate position 37°49.002' S 144° 56.340' E to a red buoy in approximate position 37° 48.960' S 144° 56.460' E.
