## SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Gippsland Ports, hereby give notice under subsection 15(1) of the following amendments to Notice No. 1 under section 15(2) of the Marine Act 1988:

1. Amendment to Schedule 109  
Waters – The Designated Port of Mallacoota

In Schedule 109 insert–

“3. Exclusive use and special purpose areas for the purposes of Clause 13.

The waters of the Port of Mallacoota within the area of water enclosed by the positions specified in the map below is a special purpose area for the purposes of Clause 13 and the following operating rules apply.

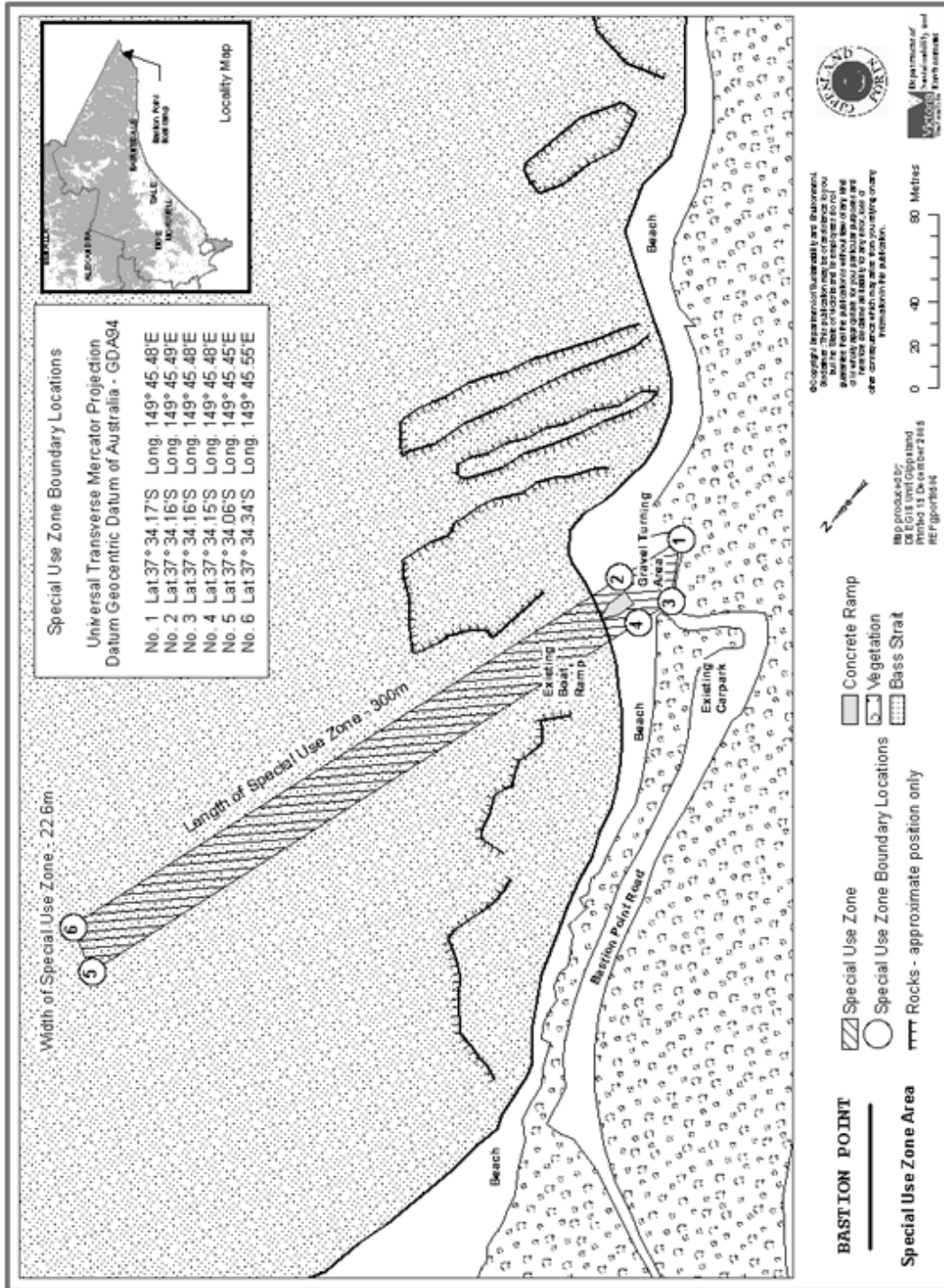
- (a) A person in charge of a vessel within the special purpose area described above–
  - (i) Must only operate the vessel at a speed consistent with safe navigation, and
  - (ii) Must not exceed 5 knots within 50 metres of vessel, bather, surfer or person engaged in a similar activity.
- (b) A bather, surfer or person engaged in a similar activity within the special purpose area described above–
  - (i) Must give way to any powered vessel operating within the special purpose area described above.”
