Water Act 1989 PROPOSED PERMANENT WATER SAVING PLAN

Lower Murray Water (LMW) is proposing to introduce permanent water saving rules for all urban and rural garden water supply systems across the LMW region from 1 January 2006, as required and outlined in Action 5.4 of the government's White Paper for Water.

Water shortages across the State led to the development of the Permanent Water Saving Plan and it is important that these new water saving rules, which will be imposed by all water authorities, are easily understood and readily adopted by our customers. Key elements of the draft Permanent Water Saving Plan include:

- Changes in the time-of-use for both automatic and manual watering systems. These include private/public gardens and lawns, and public sports and recreational grounds.
- Fountains may only be used if they recirculate water.
- A hand held hose must not be used at any time to clean a vehicle unless it is fitted with a trigger nozzle.
- Hard surfaces must not be cleaned with water from a hose unless cleaning is required as a result of an accident, fire, emergency or a health hazard has developed.
- No restrictions apply to watering of plants at wholesale, retail and municipal garden nurseries.
- Hoses used in the construction industry must be fitted with a trigger nozzle.

Lower Murray Water (LMW) is proposing to introduce a revised By-Law No. 2, Water Restrictions for Drought Response, for all urban and rural garden water supply systems across the LMW region from 1 January 2006, as required and outlined in Action 5.8 of the government's White Paper for Water.

Water shortages across the State led to the development of By-Law No. 2 Restrictions for Drought Response and the intent of the By-Law is to ensure greater uniformity by introducing a four stage uniform restriction schedule across the State of Victoria.

Key elements of By-Law No. 2 Water Restrictions for Drought Response:

- Replacing the five stage restriction schedule with a state wide uniform four stage restriction schedule.
- Increase in the number of restriction categories from fourteen to twenty-four.
- Improvement and an increase in the number of definitions.
- A listing of "Trigger Points" for all four restriction stages.
- The provision of a key word index for ease of restriction schedule access.

Proposed Water Savings Plan

Construction Industry	• Any hose must be fitted with a trigger nozzle.
Swimming Pools	• Before a pool or spa with a capacity of 10,000 litres or greater is filled for the first time, an application which includes details of measures that will be undertaken to provide water savings to offset the volumes used in filling, must be lodged with and approved by the water authority.

- (e) This determination does not confer on any person the right to broadcast the Queen's Baton Relay. It is the responsibility of the broadcaster to obtain all clearances in respect of any recordings of the Queen's Baton Relay and to otherwise comply with all laws, including without limitation, all copyright laws.

2. Cultural Program

- (a) Subject to the conditions below, the Corporation hereby determines that a broadcasting authorisation is not required in relation to the cultural program associated with the Commonwealth Games ("Cultural Program").
- (b) This determination will not apply to the Cultural Program from 7.00 pm until 12.00 midnight on the day of the opening ceremony of the Melbourne 2006 Commonwealth Games (15 March 2006), or such other times on the day of the opening ceremony as notified by the Corporation under section 56KD(2) of the Act.
- (c) This determination shall be in place for the duration of the Cultural Program.
- (d) This determination does not confer on any person the right to broadcast the Cultural Program. It is the responsibility of the broadcaster to obtain all clearances in respect of any recordings of the Cultural Program and to otherwise comply with all laws, including without limitation, all copyright laws.

3. Live Sites

- (a) Subject to the conditions below, the Corporation hereby determines that a broadcasting authorisation is not required in relation to live sites associated with the Commonwealth Games ("Live Sites").
- (b) This determination does not allow for the recording and/or broadcast of coverage of the Melbourne 2006 Commonwealth Games broadcast at the Live Sites, whether displayed on the super screens or otherwise.
- (c) This determination shall be in place for the period during which the Live Sites are operating.
- (d) This determination does not confer on any person the right to broadcast activities at Live Sites. It is the responsibility of the broadcaster to obtain all clearances in respect of any recordings made of activities at the Live Sites and to otherwise comply with all laws, including without limitation all copyright laws.

4. Additions or Variations to this determination

Additions and/or variations to this determination may be made by the Corporation from time to time by notice in accordance with section 56KD(2) of the Act.


