**Subordinate Legislation Act 1994**  
REGULATORY IMPACT STATEMENT  
Casino Control (Licence Fees)  
Regulations 2005

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Casino Control (Licence Fees) Regulations 2005.

The objective of the draft Regulations is to prescribe the licence fees that are payable for an application for a special employee's licence, for the renewal or variation of a licence, and for the issue of a replacement licence.

These fees are currently prescribed under the Casino Control (Special Employees) Regulations 1994. These Regulations are due to expire on 2 May 2005 and the Victorian Commission for Gambling Regulation has conducted a review of the Regulations with a view to replacing them with new regulations.

The RIS considers a draft of the proposed Regulations and concludes that the social benefit of the draft Regulations outweighs any costs.
