Notice of Approval of Amendment  
Amendment C100

The Minister for Planning has approved Amendment C100 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment makes changes to Schedule 2 to the Special Use Zone at Clause 37.01 by referencing the new 'Royal Melbourne Showgrounds Redevelopment Master Plan – December 2004'; amends the Schedule to Clause 52.03 to insert a new incorporated document titled 'Royal Melbourne Showgrounds Redevelopment Project – December 2004'; amends the Schedule to Clause 52.06–6 by replacing the Incorporated Parking Precinct Plan 'Car Parking in the Special Use Zone Schedule 2 – Royal Melbourne Showgrounds' with an updated version dated December 2004; and amends the Schedule to Clause 81 to delete reference to the 'Royal Melbourne Showgrounds Master Plan – August 1998' and substitute it with the 'Royal Melbourne Showgrounds Redevelopment Master Plan – December 2004' and insert the new document titled 'Royal Melbourne Showgrounds Redevelopment Project – December 2004'.
