## Marine Act 1988 SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that from 5.45 p.m. on Friday 18 March 2005 until 7.45 p.m. on Friday 18 March 2005, bathing and the operation of vessels, excluding those vessels involved with The Corporate Challenge Biathlon, The Fast and Furious Boat Building Challenge, and vessels owned and operated by Parks Victoria and Life Saving Victoria are prohibited on the following sections of the Yarra River:

The waters of Victoria Harbour within an area bounded by:

- a line extending from the western end of berth 9 Central Pier to the western end of berth 6 Victoria Harbour;
- a line extending from the western end of berth 6 Victoria Harbour to the eastern end of Berth 6 Victoria Harbour;
- a line extending from the southern end of berth 8 Victoria Harbour to the northern end of berth 8 Victoria Harbour;
- a line extending from the eastern end of berth 9 Victoria Harbour to the western end of berth 9 Victoria Harbour.

## Marine Act 1988 SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that for the period commencing 8.00 a.m. until 12.00 p.m. on Saturday 20 March 2005 and 1.00 p.m. until 5.00 p.m. on Saturday 20 March 2005, bathing and the operation of vessels, excluding those vessels and persons associated with the 2005 Victorian Dragon Boat Trials, and vessels owned and operated by Parks Victoria and vessels owned and operated by Victoria State Emergency Service, are prohibited on the waters of the Yarra River between Princes bridge and Swan Street bridge.
