NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT (RIS)

Surveying (Cadastral Surveys) Regulations 2005

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the Surveying (Cadastral Surveys) Regulations 2005.

The Surveying (Cadastral Surveys) Regulations 2005 will replace the Surveyors (Cadastral Surveys) Regulations 1995. The proposed Regulations prescribe standards for cadastral surveys; regulate and control the making of cadastral surveys by licensed surveyors; and prescribe forms and other matters relating to cadastral surveys performed under the **Surveying Act 2004**.

The RIS discusses possible alternatives to the proposed Regulations and concludes that the proposed Regulations are the best means of achieving the stated objectives.
