The Governor in Council, on the recommendation of the Minister of Health and pursuant to sections 33(7) and 34(1) of the **Health Services Act 1988** ("the Act"), appoints Kenneth David Taylor as a member of the Board of Management of Rural Northwest Health, a public hospital listed in Schedule 1 of the Act.

Schedule to the Order in Council

1. Appointment Arrangements

The appointment is part-time.

2. Period of Appointment

Mr Kenneth David Taylor is appointed from 5 April 2005 until 30 June 2006.

3. Duties and Responsibilities of the Position

The functions of the Board are outlined in section 33(2) of the **Health Services Act 1988** ("the Act").

3. Termination Arrangements

Under section 35(1) of the Act – written resignation addressed to the Governor in Council.

Under section 35(2) of the Act – removal from the board by the Governor in Council.

4. Payment Provisions

Under section 34(2) of the Act a member is entitled to be paid:

- (a) reasonable expenses incurred in holding office as a member of the board. Reasonable expenses will be paid to Mr Taylor in accordance with the *Guidelines for the Provision of Allowances for Travelling and Personal Expenses in the Victorian Public Service*; and
- (b) such remuneration as is specified in the instrument of appointment. Mr Taylor will receive remuneration at the rate of \$30,000 per annum.

5. Superannuation Obligations

Superannuation contributions will be paid by the employer in accordance with the Commonwealth's **Superannuation Guarantee Act 1992**.

6. Travel and Personal Expenses Arrangements

Under section 34(2) of the Act members are entitled to be paid expenses incurred in holding office as members of the board. Reasonable expenses will be paid to Mr Taylor in accordance with the *Guidelines for the Provision of Allowances for Travelling and Personal Expenses in the Victorian Public Service*.

7. Leave Arrangements

There are no leave provisions for this part-time statutory position.

8. Prior Service

Mr Taylor has previously served two terms.
