#### Subordinate Legislation Act 1994 NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT

Transport (Taxi-Cabs) Regulations 2005

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Transport (Taxi-Cabs) Regulations 2005.

The Regulations will replace the Transport (Taxi-Cabs) Regulations 1994. The objectives of these Regulations are to prescribe measures intended to enhance passenger and driver safety and the reliability and quality of taxi-cab services, including requirements for or in relation to -

- (a) driver certification, conduct and presentation;
- (b) vehicle construction, equipment, appearance and operation;
- (c) hirings, the charging and payment of fares and charges and the operation of taximeters;
- (d) the conduct of passengers.

The RIS explains the likely impact of the proposed Regulations and assesses the benefits and costs of the proposed Regulations and other feasible alternative means of achieving the same objectives. It concludes that the benefits of the proposed Regulations are likely to outweigh the expected costs.

The purpose of this notice is to invite public comments or submissions on the proposed Regulations or the RIS. Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Transport (Passenger Vehicles) Regulations 2005.

The Regulations will replace the Transport (Passenger Vehicles) Regulations 1994. The objective of the Regulations is to facilitate the safe and efficient operation of buses, hire cars and other small passenger vehicles (excluding taxi-cabs) and to enable comfortable and convenient travel on those vehicles.

The RIS explains the likely impact of the proposed Regulations and assesses the benefits and costs of the proposed Regulations and other feasible alternative means of achieving the same objectives. It concludes that the benefits of the proposed Regulations are likely to outweigh the expected costs.

The purpose of this notice is to invite public comments or submissions on the proposed Regulations or the RIS. Transport (Ticketing and Conduct) Regulations 2005

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Transport (Ticketing and Conduct) Regulations 2005.

The Regulations will replace the Transport (Passengers and Rail Freight) Regulations 1994. The objectives of these Regulations are to:

- (a) prescribe ticket conditions in relation to the alteration of services;
- (b) regulate the use of tickets and other behaviour with the intention of reducing fare evasion and minimising the consequential revenue losses incurred by public transport operators and the State;
- (c) regulate the use of seating and other accommodation on public transport vehicles having regard to fairness and community standards;
- (d) regulate the conduct of persons on and in relation to public transport vehicles and premises.

The RIS explains the likely impact of the proposed Regulations and assesses the benefits and costs of the proposed Regulations and other feasible alternative means of achieving the same objectives. It concludes that the benefits of the proposed Regulations are likely to outweigh the expected costs. The purpose of this notice is to invite public comments or submissions on the proposed Regulations or the RIS.
