Amendment C32

The Minister for Planning has approved Amendment C32 to the Brimbank Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment:

- applies a Public Acquisition Overlay (PAO7) over the land required for the future route of the Melbourne Airport Rail Link;
- applies a Design and Development Overlay (DDO3) over both the existing and future route of the Melbourne Airport Rail Link;
- applies a Development Plan Overlay (DPO12) over both the existing and future route of the Melbourne Airport Rail Link;
- deletes the Design and Development Overlay (DDO1) from land within the rail reservation;
- deletes the Public Acquisition Overlay (PAO1) from land within the rail reservation;
- exempts the Melbourne Airport Rail Link from the requirement for a permit for buildings and works in locations where the Special Building Overlay (SBO) exists over the rail reservation; and
- amends the Schedule to Clauses 61.01-61.04 to reflect the inclusion of new overlay maps (5DDO, 6DDO, 6DPO, 6PAO, 12DDO and 12DPO) within the scheme and to expand the Minister's responsibilities as Responsible Authority in relation to the Melbourne Airport Rail Link.

- deletes the Design and Development Overlay (DDO1) from land within the rail reservation;
- deletes the Incorporated Plan Overlay (IPO1) from land within the rail reservation;
- exempts the Melbourne Airport Rail Link from the requirement for a permit for buildings and works in locations where the Land Subject to Inundation Overlay (LSIO) and the Special Building Overlay (SBO) exists over the rail reservation; and
- amends the Schedule to Clauses 61.01-61.04 to reflect the inclusion of new overlay maps (1DDO, 1DPO, 2DDO, 2DPO, and 5DPO) within the scheme and to expand the Minister's responsibilities as Responsible Authority in relation to the Melbourne
