GAMBLING REGULATION (SIGNAGE) REGULATIONS 2005

Notice of Decision

I, John Pandazopoulos, Minister for Gaming, give notice under section 12 of the **Subordinate Legislation Act 1994**, of my decision to recommend to the Governor in Council that the proposed Gambling Regulation (Signage) Regulations 2005 be made.

Objective and effect of the proposed Regulations

The objective of the proposed Gambling Regulation (Signage) Regulations 2005 is to prescribe signs that are excluded from the operation of section 3.5.35 of the **Gambling Regulation Act 2003** which prohibits the display of gaming machine related signs.

Receipt of submissions

A Regulatory Impact Statement (RIS) was prepared for the proposed Gambling Regulation (Signage) Regulations 2005 and the public was invited to make written submissions on the proposed Gambling Regulation (Signage) Regulations 2005 and the RIS. Eight submissions were received.

Changes to the proposed Regulations

No changes to the proposed Gambling Regulation (Signage) Regulations 2005 as published in the RIS have been made.

The proposed Gambling Regulation (Signage) Regulations 2005 will commence on 1 July 2005.

 - a. gaming machines;
 - b. wagering and betting;
 - c. trade promotion lotteries;
 - d. club keno;
 - e. community and charitable gaming; and
- 2. fees; and
- 3. other matters-

that are authorised or required to be prescribed by the Gambling Regulation Act 2003.

Receipt of submissions

A Regulatory Impact Statement (RIS) was prepared for the proposed Gambling Regulation Regulations 2005 and the public was invited to make written submissions on the proposed Gambling Regulation Regulations 2005 and RIS. Three submissions were received.

Changes to the proposed Regulations

Some amendments of a minor and technical nature have been made to the proposed Gambling Regulation Regulations 2005 as published in the RIS.
