Mitcham-Frankston Project Act 2004 (Vic.)

NOTICE TO UTILITIES THAT OWN OR OPERATE UTILITY INFRASTRUCTURE IN THE EXTENDED PROJECT AREA

On 18 February 2005 Thiess Pty Ltd and John Holland Pty Ltd, jointly as delegates of the Freeway Corporation, gave notice of the construction works for the Mitcham–Franskton Project.

By notices published in the Government Gazette on 16 March 2005 and 17 May 2005, the Governor in Council varied the Extended Project area, as defined in section 6 of the **Mitcham–Frankston Project Act 2004** ('the Act').

Details of the varied Extended Project area are shown as cross-hatched on the plans located at the Central Plan Office of the Department of Sustainability and Environment and numbered:

• LEGL./05–008, LEGL./05–012 to LEGL./05–014 (inclusive) and LEGL./05–016 to LEGL./05–018 (inclusive); and

shown as shaded or cross-hatched on the plans located at the Central Plan Office of the Department of Sustainability and Environment and numbered:

- LEGL./05–044 to LEGL./05–069 (inclusive), LEGL./05–047, LEGL./05–048, LEGL./05–061, LEGL./05–64 and LEGL./05–065; and
- LEGL./05–076 and LEGL./05–077.

Pursuant to section 160(2) of the Act, Thiess Pty Ltd and John Holland Pty Ltd jointly as delegates of the Freeway Corporation hereby give notice of the construction works for the Mitcham–Frankston Project as detailed in the drawings available for inspection at 68 Ricketts Road, Mount Waverley in the varied Extended Project area. It is expected that the works will impact on several utilities services infrastructure.

As required by section 160(3) of the Act, Utilities with Utility infrastructure in the varied Extended Project area are required to notify the Thiess Pty Ltd and John Holland Pty Ltd jointly within 30 business days after the later date of this notice being published in the Government Gazette and the date on which this notice is given to the Utility:

- (a) setting out the nature and location of the Utility infrastructure within the varied Extended Project area; and
- (b) stating whether or not the Utility believes that the Utility infrastructure will be affected by the Project construction work.
