## Marine Act 1988

### SECTION 15 NOTICE

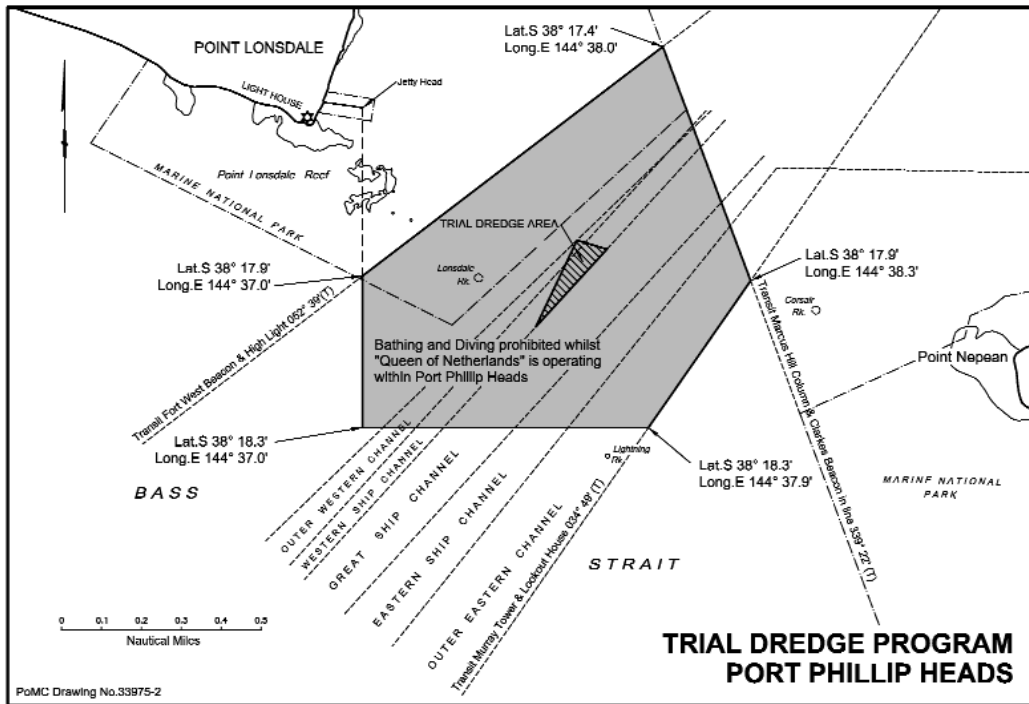
I, the Director of Marine Safety, on the recommendation of Senior Sergeant Rex Brown, a member of Victoria Police, hereby give notice under subsection 15(2) of the **Marine Act 1988** that from Tuesday 2 August 2005 until Saturday, 15 October 2005 within Victorian State Waters and waters of the Port of Melbourne:

1. The operation of vessels, excluding vessels associated with the operation of the Queen of the Netherlands and vessels approved by the Port of Melbourne Harbour Master, are prohibited within 100 metres of the Queen of the Netherlands whilst the vessel is underway.
2. Bathing and diving, without prior approval from the Port of Melbourne Harbour Master or the Master of the Queen of the Netherlands are prohibited:
  - a. Within 500 metres of the Queen of the Netherlands whilst the vessel is underway, and
  - b. within the area bounded within lines connecting the following positions (WGS84) whilst the Queen of the Netherlands is underway within this defined area:

From	38° 17.4' S	144° 38.0' E to
	38° 17.9' S	144° 38.3' E to
	38° 18.3' S	144° 37.9' E to
	38° 18.3' S	144° 37.0' E to
	38° 17.9' S	144° 37.0' E returning to
	38° 17.4' S	144° 38.0' E
