### Casino Control Act 1991 – section 60(1) CASINO RULES NOTICE NO. 4 OF 2005

Rules of the Game - Baccarat

By this notice, the Victorian Commission for Gambling Regulation **amends** the Rules in respect of the game "Baccarat"<sup>1</sup> as set out in the Schedule.

This notice operates with effect from 4.00 am on 8 July 2005.

#### Schedule

In "definitions" at rule 1.1;

"Dragon Bonus" means an additional wager which may be offered on both Traditional Baccarat and Crown Baccarat and may be placed on:

- a) Player Dragon Bonus Player wins by 4 points or more, or wins with a Natural; and/or
- b) Banker Dragon Bonus Banker wins by 4 points or more, or wins with a Natural.

**Replace** rule 2.2 with;

- 2.2 The table layout will be marked in a manner similar to the diagrams marked:-
  - 2.2.1 "A" Baccarat
  - 2.2.2 "B" Mini Baccarat
  - 2.2.3 "C" Midi Baccarat

After rule 2.4 **insert** rule 2.5;

2.5 Where the "Dragon Bonus" betting option is offered, additional betting areas will be provided for Player Dragon Bonus wagers and Banker Dragon Bonus wagers in a manner similar to that described in Diagram E.

## SPECIAL

After rule 6.5.8 insert;

- 6.5.9 Player Dragon Bonus; and
- 6.5.10 Banker Dragon Bonus.

#### **Replace** rule 6.6 with;

6.6 A wager may be refused prior to the cards being dealt for a round of play if in the event the wager wins, it would not be possible to pay the wager exactly in chips.

#### After rule 6.7 **insert**;

- 6.8 Where the Dragon Bonus betting option is offered:
  - 6.8.1 A player may place a Dragon Bonus wager regardless of whether they or any other player has placed a valid wager on Player, Banker or Tie.
  - 6.8.2 A player may place simultaneous wagers on Player Dragon Bonus and Banker Dragon Bonus.
  - 6.8.3 A player who has placed a valid Player wager on a specific betting area will have first entitlement to place a Player Dragon Bonus wager in the corresponding area for Player Dragon Bonus wagers.
  - 6.8.4 A player who has placed a valid Banker wager on a specific betting area will have first entitlement to place a Banker Dragon Bonus wager in the corresponding area for Banker Dragon Bonus wagers.
  - 6.8.5 A player who has placed a valid wager, other than a Player wager on a specific betting area, will have next entitlement to place a Player Dragon Bonus wager in the corresponding betting area.
  - 6.8.6 A player who has placed a valid wager, other than a Banker wager on a specific betting area, will have next entitlement to place a Banker Dragon Bonus wager in the corresponding betting area.
  - 6.8.7 Once players with first entitlement as described in 6.8.2 to 6.8.5 above have elected to place a Dragon Bonus wager or not, subsequent entitlements will go to the remaining players.

Amend footnote in rule 7.1 to read;

#### 66. Assistance to patrons

- (1) A casino operator must–
  - (c) display prominently at each gaming table or location related to the playing of a game, a sign indicating the permissible minimum and maximum wagers pertaining to the game played there.
- (2) A casino operator must ensure that a minimum wager indicated in respect of a game at a table or location is not changed to a higher minimum unless a sign indicating the new minimum and the proposed time of change is displayed at the table or location at least 20 minutes before the time of proposed change. 50 penalty units.

At rule 10.1, after the "Baccarat Runs" settlement table insert;
