## Local Government Act 1989

### SUSPENSION OF COUNCILLORS OF THE GLEN EIRA CITY COUNCIL AND APPOINTMENT OF AN ADMINISTRATOR

#### Order in Council

The Minister for Local Government, Candy Broad, has made a recommendation pursuant to s.219(1) of the **Local Government Act 1989** that all the Councillors of the Glen Eira City Council be suspended (the Minister being satisfied on reasonable grounds that there has been a serious failure by Glen Eira City Council to provide good government, and having considered the steps the Council has taken to address and remedy the difficulties underlying the failure);

The Minister for Local Government being the Minister responsible for the administration of the **Local Government Act 1989** has also recommended that the Governor in Council exercise the power conferred by section 219(2) of the **Local Government Act 1989** to suspend all of the Councillors of Glen Eira City Council, and to appoint Mr John Lester as an administrator for the Council and to exercise the power conferred by section 219(4) to specify the date this Order is made.

Therefore the Governor in Council acting pursuant to the power conferred by subsections 219(2) and (4) of the **Local Government Act 1989** by this Order in Council

HEREBY –

- (a) suspends all the Councillors of the Glen Eira City Council;
- (b) appoints Mr John Lester to be the administrator of the Glen Eira City Council; and
- (c) specifies that this Order takes effect from 11 August 2005.
