ROAD SAFETY (VEHICLES) REGULATIONS 1999

Notice declaring Container Vehicle Routes

Regulation 105(2)(c) of the Road Safety (Vehicles) Regulations 1999 provides that the Roads Corporation may by notice published in the Government Gazette declare a container vehicle route for the purposes of those Regulations.

In accordance with that provision, I, Ted Vincent, delegate of the Roads Corporation, declare the following routes to be container vehicle routes –

FOOTSCRAY

Whitehall Street between Napier Street and Hopkins Street

Hopkins Street between Whitehall Street and Dynon Road

PORT MELBOURNE

Cook Street between Todd Road and West Gate Freeway on ramp

Dockside Road

Lorimer Street between Todd Road and Docklands Highway (Montague Street)

Todd Road between Lorimer Street and Williamstown Road

West Gate Freeway between Docklands Highway (Montague Street) and the on ramp at Cook Street and the off ramp at Todd Road

West Gate Freeway off ramp at Todd Road

West Gate Freeway on ramp at Cook Street

Williamstown Road between Todd Road and Yarra River

APPLETON, SWANSON AND VICTORIA DOCKS AREA

Anderson Road

Appleton Dock Road

Coode Road

Dock Link Road

Enterprize Road

Gibbons Street

Mackenzie Road

Oliphant Street

WEST MELBOURNE

Docklands Highway between Whitehall Street and West Gate Freeway

Dynon Road between Hopkins Street and Link Road (Western Link) with no travel over the Moonee Ponds Creek Bridge

Lloyd Street between Radcliffe Street and the rail yards with no travel under any overhead rail bridge

Radcliffe Street

Sims Street

In this Notice, unless the contrary intention appears, expressions used have the same meaning as in the **Road Safety Act 1986** and the Road Safety (Vehicles) Regulations 1999.

SPECIAL

Nothing in this Notice authorizes the driving of a container vehicle in a manner or in a condition or place that is otherwise prohibited by the Regulations.

This Notice operates from the date of its publication in the Victoria Government Gazette until 1 December 2009.
