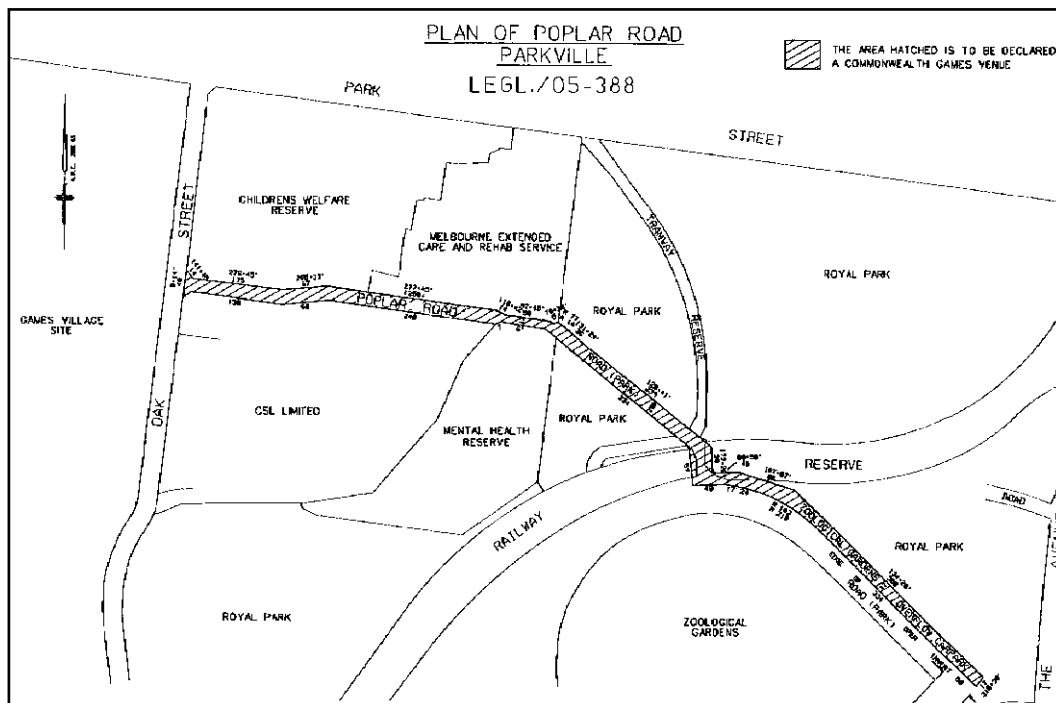
## Commonwealth Games Arrangements Act 2001

### COMMONWEALTH GAMES VENUE ORDER

In accordance with section 14 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), as the Minister administering the Act, I declare the following area of land to be a Commonwealth Games venue to which the Act applies:

the area comprising Poplar Road and areas adjoining the road which are defined by the hatched areas within the solid line, and shown on the plan of survey numbered LEGL./05-388 and attached to this venue Order.

This Order shall take effect from the date of its publication in the Government Gazette and cease at 11.59 pm on 31 July 2006.

### COMMONWEALTH GAMES PROJECT ORDER

In accordance with section 15 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), as the Minister administering the Act, I declare works in Poplar Road and areas adjoining the road a project to develop facilities at a Commonwealth Games venue as shown hatched in plan of survey numbered LEGL./05-388 to be a project to which the Act applies and I authorise the development of that project for the period commencing 7 September 2005 and until 11.59 pm on 31 July 2006.

**SPECIAL**

In accordance with section 17 of the Act I specify that the Secretary to the Department of Victorian Communities, being a body corporate constituted under section 25A of the Act, as the body responsible for managing or developing the Commonwealth Games project to which this Order applies.

This Order shall take effect from the date of its publication in the Government Gazette.
