## Subordinate Legislation Act 1994 REGULATORY IMPACT STATEMENT

Gambling Regulation  
(Commercial Raffle Organisers)  
Regulations 2006

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Gambling Regulation (Commercial Raffle Organisers) Regulations 2006.

The **Gambling Regulation (Further Amendment) Act 2004** introduces into the **Gambling Regulation Act 2003** a new licensing scheme for commercial raffle organisers. The relevant sections of the **Gambling Regulation (Further Amendment) Act 2004** will commence on 1 July 2006. The objective of the proposed Regulations is to prescribe certain matters to support the effective implementation of the licensing scheme.

The RIS considers a draft of the proposed Regulations and concludes that the benefit of the draft Regulations outweighs any costs.
