ORDER DECLARING A RESTRICTED AREA AT RUTHERGLEN FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Bob Cameron, Minister for Agriculture, under sections 20 and 22 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of the exotic pest, Queensland Fruit Fly and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

1. Objective

The objective of this Order is to declare a restricted area for the control of Queensland Fruit Fly at Rutherglen and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

2. Authorising provisions

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

3. Definition

In this Order-

- (a) "Act" means the Plant Health and Plant Products Act 1995; and
- (b) "Queensland Fruit Fly" means the exotic pest *Bactrocera tryoni* (Froggart); and
- (c) "Regulations" mean the Plant Health and Plant Products Regulations 1996.

4. Restricted area for the control of Queensland fruit fly

The restricted area for the control of Queensland Fruit Fly is declared to be the area described in Schedule 1.

5. Prohibitions, restrictions and requirements

- (1) The removal from the restricted area into any part of Victoria of any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations is prohibited unless the fruit or vegetable is accompanied by a Plant Health Certificate, Assurance Certificate or Plant Health Declaration, and, in the case of fruit for treatment, packing or processing outside the restricted area, is accompanied by a permit issued by an inspector under section 21 of the Act.
- (2) The owners and occupiers of land described in Schedule 2 must give access to such land at all times to an inspector, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspection, placing on such land any lures or traps, applying on such land any spray material or bait and performing any other actions in accordance with section 52 of the Act which in the opinion of the authorised officer are necessary for the eradication or prevention or spread of the pest.
- (3) The owners and occupiers of land described in Schedule 2, on instruction from an inspector, must strip fruit from trees, collect and dispose of waste fruit, or treat fruit and vegetables listed as hosts of Queensland Fruit Fly in Schedule 5 of the Regulations in a manner approved by the Secretary.

SPECIAL

- (4) Any fruit or vegetable listed as a host of Queensland Fruit Fly in Schedule 5 of the Regulations which is transported through the restricted area, from areas free of Queensland Fruit Fly, must be transported in accordance with the conditions of a permit issued by an inspector under section 21 of the Act.
- (5) A person responsible for importing, introducing or bringing any fruit or vegetable listed as a host of Queensland Fruit Fly in Schedule 5 of the Regulations into any part of Victoria from the restricted area is required to present the material for inspection, examination or treatment and the accompanying plant health certificate, assurance certificate, or plant health declaration for inspection and examination at a place prescribed in the Regulations or a place nominated by an inspector.

Schedule 1

The area of land bounded by a line commencing where the McConnell Lane intersects the Murray River, then in a south-westerly direction along McConnell Lane to the intersection of McConnell Lane and Police Paddocks Road, then in a southerly direction along Police Paddocks Road to the intersection of Police Paddocks Road and Up River Road, then in an easterly direction along Up River Road to the intersection of Up River Road and Gooramadda Road then in an easterly direction along Gooramadda Road to the intersection of Gooramadda Road and Chiltern-Howlong Road, then in a southerly direction along the Chiltern-Howlong Road to the intersection of Chiltern-Howlong Road and Fishers Road, then in a straight line in a south-westerly direction to the intersection of Chiltern Valley Road and Peaks Road, then in a straight line in a south-westerly direction to the intersection of Rutherglen-Springhurst Road and Developmental Road, then in a westerly direction along Developmental Road to the intersection of Developmental Road and Three Chain Road, then in a northerly direction along Three Chain Road to the intersection of Three Chain Road and Boundary Road, then in a westerly direction along Boundary Road to the intersection of Boundary Road and Lewis Road, then in a northerly direction along Lewis Road to the intersection of Lewis Road and McPhersons Road, then in a westerly direction along McPhersons Road to the intersection of McPhersons Road and O'Keefe Road, then in a northerly direction along O'Keefe Road to the intersection of O'Keefe Road and Clohesseys Road, then in a westerly direction along Clohesseys Road, which becomes Taylors Bridge Road to the intersection of Taylors Bridge Road and Boorhaman East Road, then in a northerly direction along Boorhaman East Road to the intersection of Boorhaman East Road and Lilliput-Norong Road, then in a westerly direction along Lilliput-Norong Road to the intersection of Lilliput-Norong Road and Paris Road, then along Paris Road in a northerly direction to the end of Paris Road, then in a straight line in a northerly direction until the line intersects with the Murray River, then along the Murray River in an easterly direction to the point of commencement.

The area of land within a radius of one and a half kilometres of the point 36.05612° South, 146.46533° East.

2. Authorising provisions

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

3. Definition

In this Order-

- (a) "Act" means the Plant Health and Plant Products Act 1995; and
- (b) "Queensland Fruit Fly" means the exotic pest Bactrocera tryoni (Froggart); and
- (c) "Regulations" mean the Plant Health and Plant Products Regulations 1996.

4. Restricted area for the control of Queensland fruit fly

Schedule 1

The area of land bounded by a line commencing at the intersection of the Great Alpine Road and the Hume Freeway, then in a north-easterly direction along the Hume Freeway to the intersection of the Hume Freeway and Benton Road, then in an easterly direction along Benton Road to the intersection of Benton Road and Vipond Road, then in a southerly direction along Vipond Road to the intersection of Vipond Road and Sanderson Road, then in an easterly and south-easterly direction along Sanderson Road to the intersection of Sanderson Road and West Triangle Road, then in a north-easterly direction along West Triangle Road, which becomes Water Trust Road, to the intersection of Water Trust Road and Edgar Track, then in a south-easterly direction along Edgar Track to the intersection of Edgar Track and Pine Road, then in a north-easterly direction along Pine Road to the intersection of Pine Road and Beechworth-Chiltern Road, then in a south-easterly direction along Beechworth-Chiltern Road to the intersection of Beechworth-Chiltern Road and Ponds Track, then in a south-westerly direction along Ponds Track to the intersection of Ponds Track and Malakoff Road, then in a south-easterly direction along Malakoff Road to the intersection of Malakoff Road and Old Tannery Road, then in a south-westerly direction along Old Tannery Road to the intersection of Old Tannery Road and Beechworth-Wangaratta Road, then in a south-westerly direction along Beechworth-Wangaratta Road to the intersection of Beechworth-Wangaratta Road and Boundary Road, then in a southerly direction along Boundary Road to the intersection of Boundary Road and White Post Road, then in a southerly direction along White Post Road to the intersection of White Post Road and the Great Alpine Road, then in a westerly direction along the Great Alpine Road to the point of commencement.

The area of land within a radius of one and a half kilometres of the point 36.30872° South, 146.52183° East.
