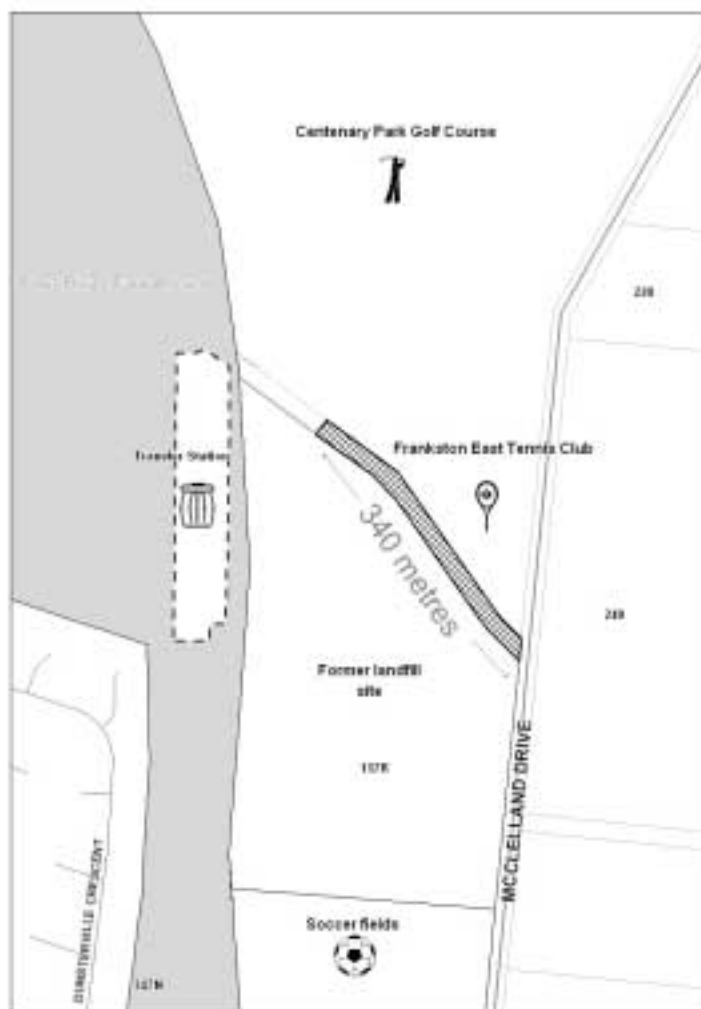

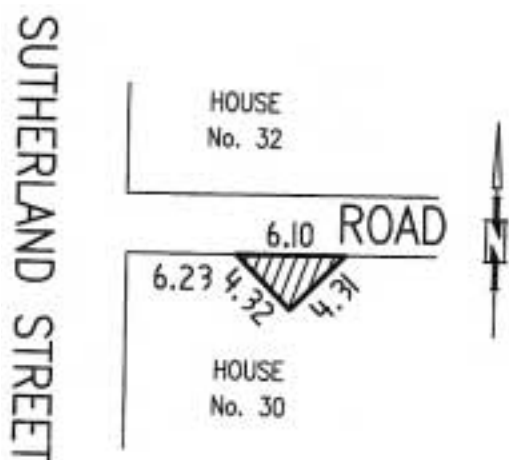

The Ballarat City Council has prepared Amendment C88 to the Ballarat Planning Scheme.

In accordance with section 9(2) of the **Planning and Environment Act 1987**, the Minister for Planning authorised the Ballarat City Council as planning authority to prepare the Amendment.

The land affected by the Amendment is all industrial land within the municipality, in particular many of the 43 precincts identified in the Ballarat Industrial Land Use Strategy 2005, as well as a greenfield site abutting the Midland Highway and Western Freeway.

The Amendment implements the recommendations of the Ballarat Industrial Land Use Strategy 2005 and Council's adoption of the review of the recommendations. In particular, the Amendment:

- makes minor changes to the Municipal Strategic Statement at clauses 21.03, 21.05, 21.06 and 21.08 to enhance the strategies for industrial development and to reference the Ballarat Industrial Land Use Strategy 2005.
- Replaces clause 22.05 with a new Industrial Land Policy, which implements the findings and recommendations of the Ballarat Industrial Land Use Strategy 2005.
- Makes a number of rezonings and application of overlay controls to implement the recommendations of the Ballarat Industrial Land Use Strategy 2005.

“**spiralling whitefly host material**” means any plant or part of a plant intended for propagation in a glasshouse, hothouse or indoor area.

**5. Controls applying to spiralling whitefly**

(1) The entry or importation into Victoria of any spiralling whitefly host material is prohibited.

(2) Sub-clause (1) does not apply if —

(a) the spiralling whitefly host material was sourced from a property that is located in a State or Territory, or part of a State or Territory, for which an area freedom certificate issued by an officer responsible for agriculture in the State or Territory where the spiralling whitefly host material was grown is currently in force certifying that the State or Territory or that part of the State or Territory is free of spiralling whitefly; or

(b) the spiralling whitefly host material is accompanied by an assurance certificate issued by a person who is accredited by the department responsible for agriculture in the affected State or Territory or a plant health certificate issued by an officer of the department responsible for agriculture in the affected State or Territory certifying that the spiralling whitefly host material was—

(i) grown on property located more than 10km from a known infestation of spiralling whitefly; or

(ii) treated in a manner approved by the Manager Plant Standards.

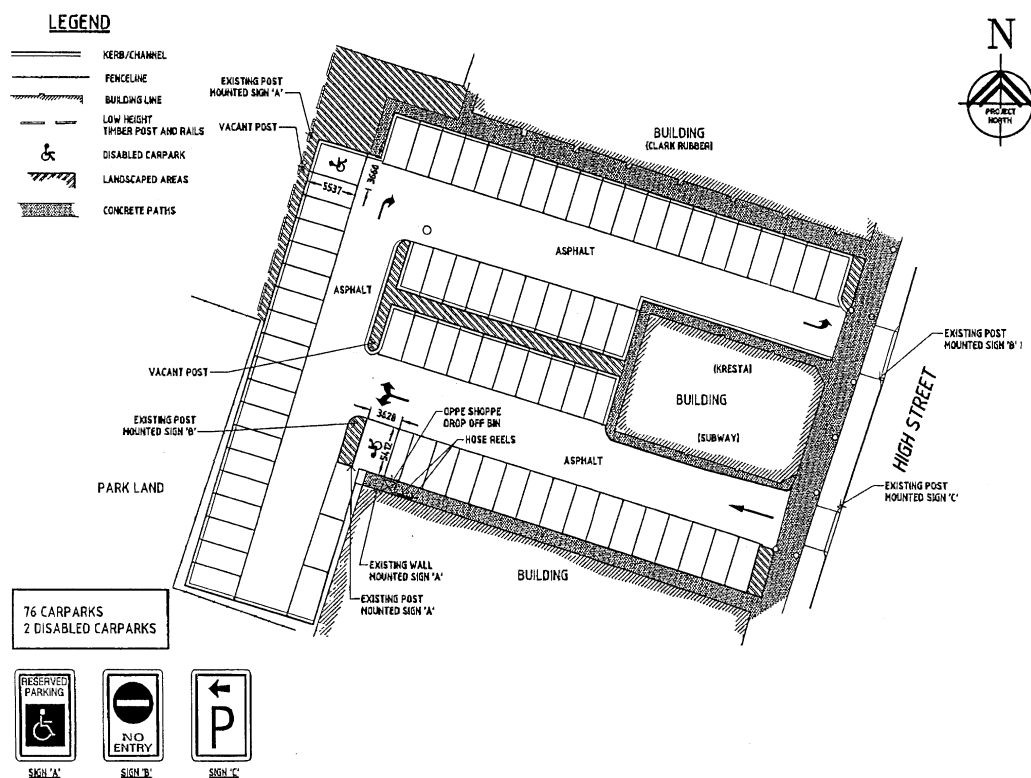

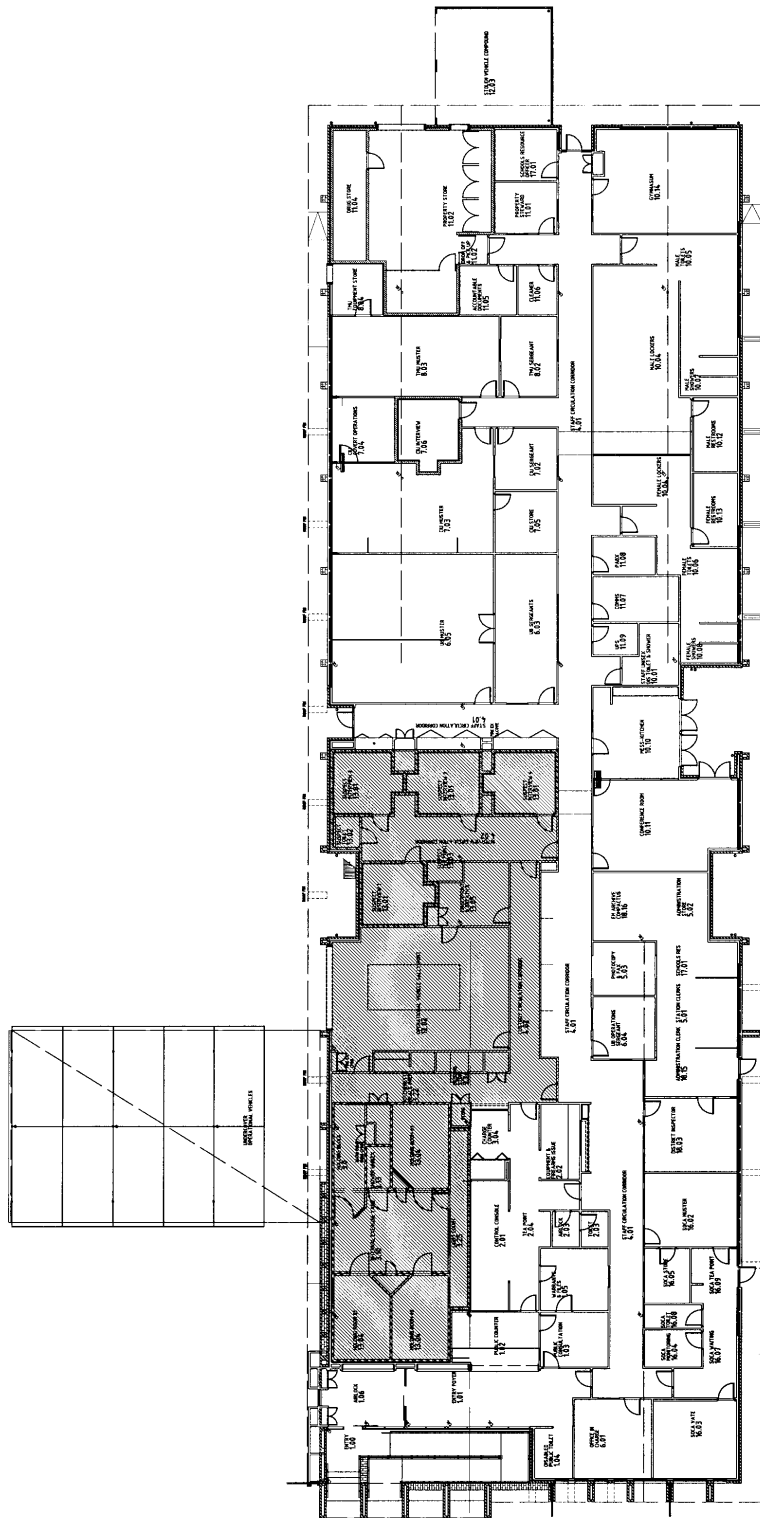
