### Road Safety Act 1986 SECTION 99B Karak Classic Road Race

### Partial Exemption from Road Rules

### Purpose

1. The purpose of this notice is to exempt participants and officials in the Karak Classic Bicycle Road Race on Sunday 29 January 2006 ("the Event") from certain Road Rules.

### Background

- 2. The Melbourne 2006 Commonwealth Games Corporation, established by the **Commonwealth Games Arrangements Act 2001**, has applied under section 99B of the **Road Safety Act 1986** for certain exemptions for the purposes of the Event.
- 3. Permits have been issued by the relevant authorities for the conduct of the Event, in particular
  - a. The Roads Corporation ("VicRoads") and the City of Melbourne have issued permits under section 99B of the **Road Safety Act 1986** for the conduct of the Event as non-road activity; and
  - b. Victoria Police have issued a permit under regulation 403 of the Road Safety (Road Rules) Regulations 1999 for the conduct of the Event.

### Permit

- 4. I, Peter Batchelor, Minister for Transport, acting under section 99B(4) of the **Road Safety Act 1986** ("the Act") and on the application of Melbourne 2006 Commonwealth Games Corporation established by the **Commonwealth Games Arrangements Act 2001** declare that the provisions of the Road Rules within the meaning of the Road Safety (Road Rules) Regulations 1999 (other than the provisions referred to in Schedule 1) do not apply to the non-road activities specified in column 1 of Schedule 2 conducted on the highways or parts of highways specified in column 2 of Schedule 2 during the periods specified in column 3 of Schedule 2, subject to the limitations specified in paragraph 6 and the conditions specified in paragraph 7.
- 5. The description in column 2 of Schedule 2 of the provisions referred to in column 1 of that Schedule is for information purposes only and does not extend or limit the extent of an exemption or of a limitation on an exemption.

### Limitations

- 6. The exemptions under this notice are limited to persons who are registered as participants in the event who hold either–
  - a. a current International Racing Licence; or
  - b. a current Australian Domestic Racing Licence-

issued by the International Cycling Union - Australian Cycling Federation.

### Conditions

- 7. Exemptions are subject to compliance at all relevant times with the following conditions:
  - a. That a permit has been issued in respect of the relevant non-road activity by the responsible road authority under section 99B(1) of the Act.
  - b. That the parts of the highways used for the non-road activity are closed to traffic by the responsible road authority under section 99B(2) of the Act during the times when the activity is actually being carried out (which may not be the full period referred to in column 3 of the Schedule).



- c. That all safety requirements are complied with including (without limitation), all other provisions of the Act, the Road Rules Victoria, the **Road Management Act 2004** and the **Occupational Health and Safety Act 2004** and any regulations under those Acts.
- d. That a copy of this Notice and any permit under section 99B(1) of the Act is produced on demand to any member of the police force or to any person who is an authorised officer under section 71 of the **Road Management Act 2004**.

### Road Safety Act 1986 SECTION 99B

### Karak Classic Road Race Partial Exemption from Road Rules for Officials

#### Purpose

1 The purpose of this notice is to exempt support staff and officials in relation to the Karak Classic Bicycle Road Race on Sunday 29 January 2006 ("the Event") from certain Road Rules.

#### Background

- 2 The Melbourne 2006 Commonwealth Games Corporation, established by the Commonwealth Games Arrangements Act 2001, has applied under section 99B of the Road Safety Act 1986 for certain exemptions for the purposes of the Event.
- 3 Permits have been issued by the relevant authorities for the conduct of the Event, in particular–
  - a. The Roads Corporation ("VicRoads") and the City of Melbourne have issued permits under section 99B of the **Road Safety Act 1986** for the conduct of the Event as non-road activity; and
  - b. Victoria Police have issued a permit under regulation 403 of the Road Safety (Road Rules) Regulations 1999 for the conduct of the Event.

### Permit

- 4 I, Peter Batchelor, Minister for Transport, acting under section 99B(4) of the **Road Safety Act 1986** ("the Act") and on the application of Melbourne 2006 Commonwealth Games Corporation established by the **Commonwealth Games Arrangements Act 2001** ("the Corporation") declare that the provisions of the Road Rules within the meaning of the Road Safety (Road Rules) Regulations 1999 (other than the provisions referred to in Schedule 1) do not apply to the non-road activities specified in column 1 of Schedule 2 conducted on the highways or parts of highways specified in column 2 of Schedule 2 during the periods specified in column 3 of Schedule 2, subject to the limitations specified in paragraph 6 and the conditions specified in paragraph 7.
- 5 The description in column 2 of Schedule 2 of the provisions referred to in column 1 of that Schedule is for information purposes only and does not extend or limit the extent of an exemption or of a limitation on an exemption.

#### Limitations

- 6 The exemptions under this notice are limited to the persons who are listed in column 1 of Schedule 3 whilst that person is actually performing the function referred to in column 2 of Schedule 3 in relation to the Event and not at other times.
- 7 A person is only exempt under this notice if the person
  - a. holds
    - i. a current Victorian driver licence or permit; or
    - ii. a driver licence or permit issued in another State or Territory or in another country that is a licence or permit to which regulation 221 of the Road Safety (Drivers) Regulations 1999 applies; and
  - b. carries
    - i. the licence or permit referred to in paragraph a; and
    - ii. an identification card or other document issued by the Corporation bearing a recent photograph of the person –

whilst that person is performing the functions specified in column 2 of Schedule 3; and

c. produces that licence or permit and that identification card or other document to any Police officer on demand.

#### Conditions

- 8 Exemptions are subject to compliance at all relevant times with the following conditions:
  - a. That a permit has been issued in respect of the relevant non-road activity by the responsible road authority under section 99B(1) of the Act.
  - b. That the parts of the highways used for the non-road activity are closed to traffic by the responsible road authority under section 99B(2) of the Act during the times when the activity is actually being carried out (which may not be the full period referred to in column 3 of the Schedule).
  - c. That all safety requirements are complied with including (without limitation), all other provisions of the Act, the Road Rules Victoria, the **Road Management Act** 2004 and the **Occupational Health and Safety Act 2004** and any regulations under those Acts.
  - d. That a copy of this Notice and any permit under section 99B(1) of the Act is produced on demand to any member of the police force or to any person who is an authorised officer under section 71 of the **Road Management Act 2004**.
  - e. That any vehicle driven by a person to whom this notice applies does not exceed a speed of 80 km/h.
  - f. That any vehicle driven by a person to whom this notice applies does not obstruct a bicycle rider who is a participant in the Event.
