VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice discontinues the part of the road described in Schedule B and on the plan attached and approves the sale of the surplus land as provided in section 47 of the **Transport Act 1983** and as delegated by the Minister of Transport under section 32 of the latter said Act.

- c) Those parts of Hallam Road identified by hatching on the plans numbered GP20898, GP20899 and GP20900 are declared as described in the legend in the said plans.

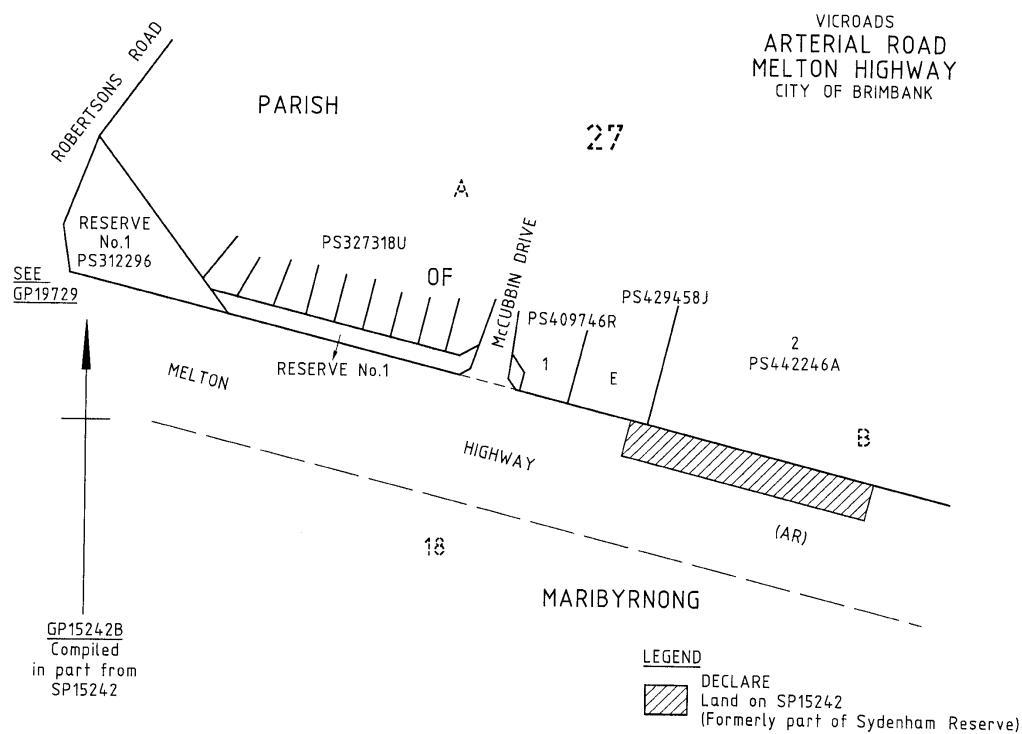
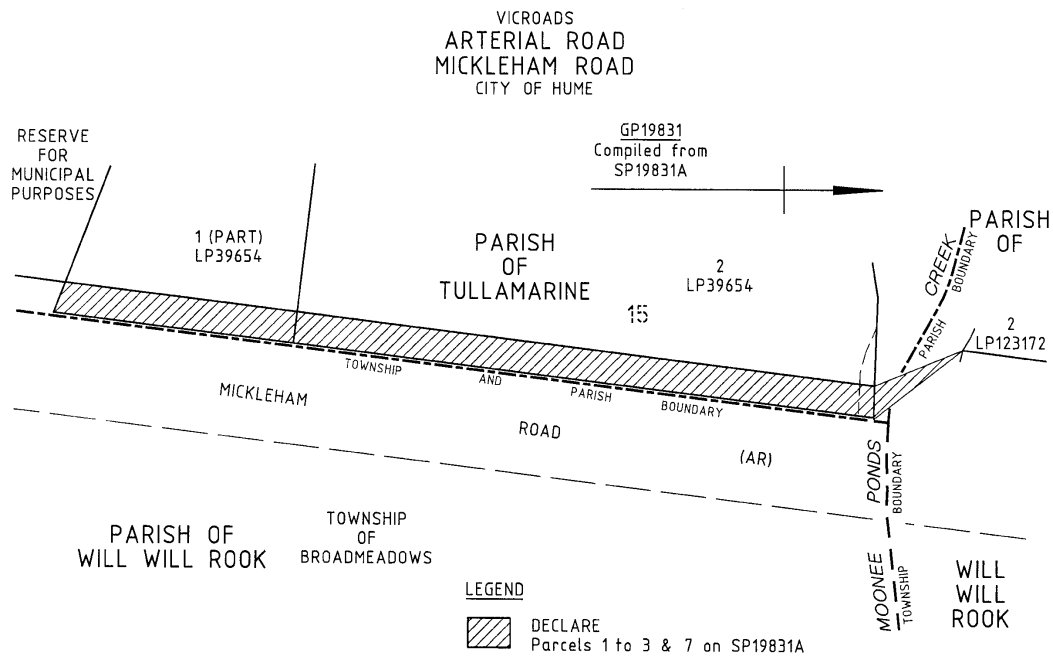

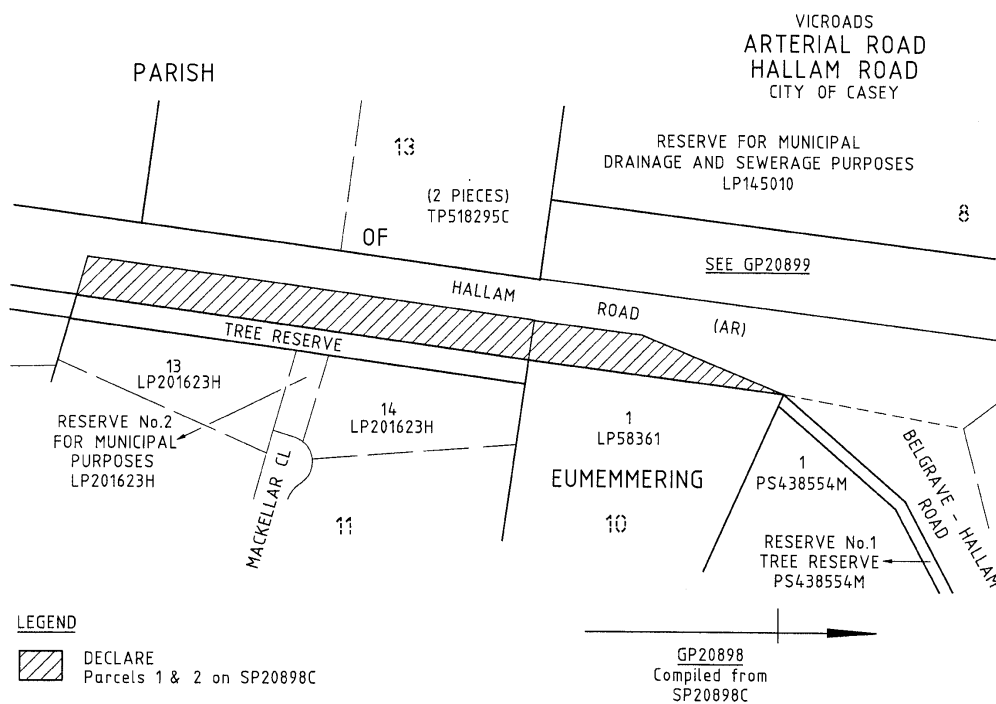
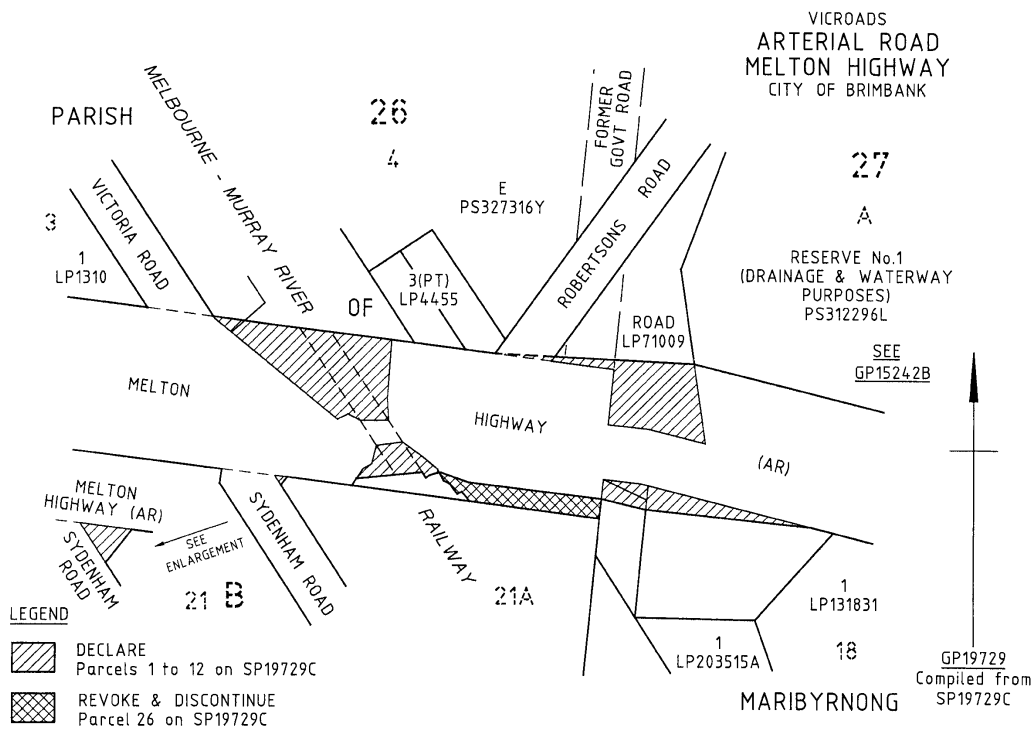
- d) That part of James Cook Drive identified by hatching on the plan numbered GP20900A is declared as described in the legend in the said plan.
- e) Those parts of King Street and Union Road identified by hatching on the plan numbered GP21034 are declared as described in the legend in the said plan.

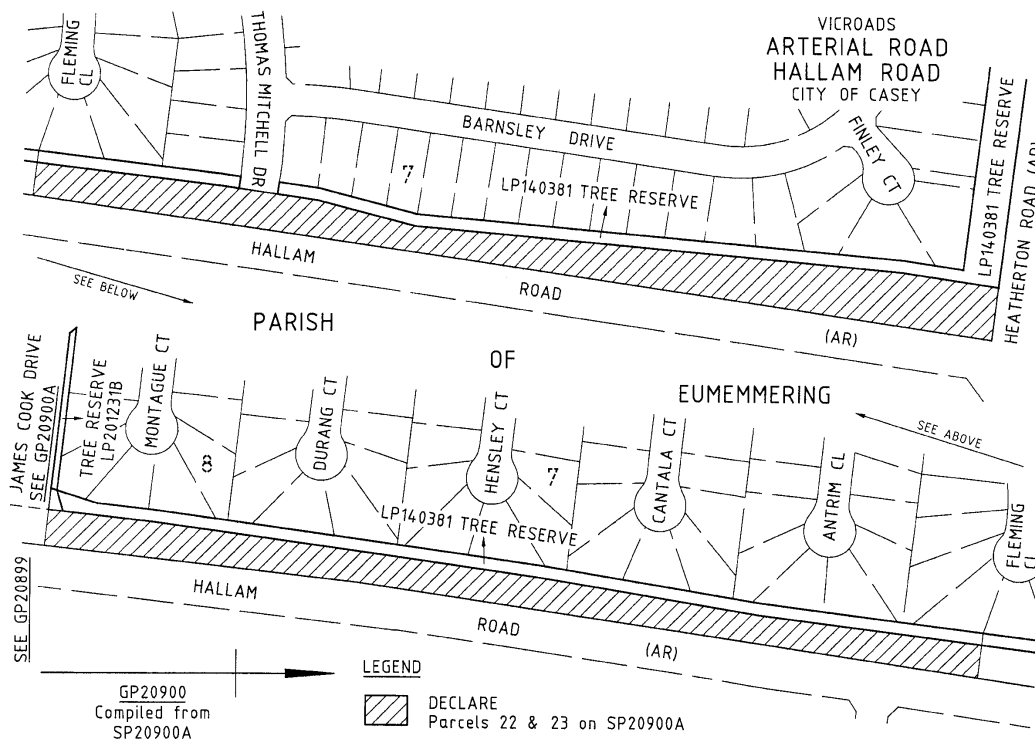
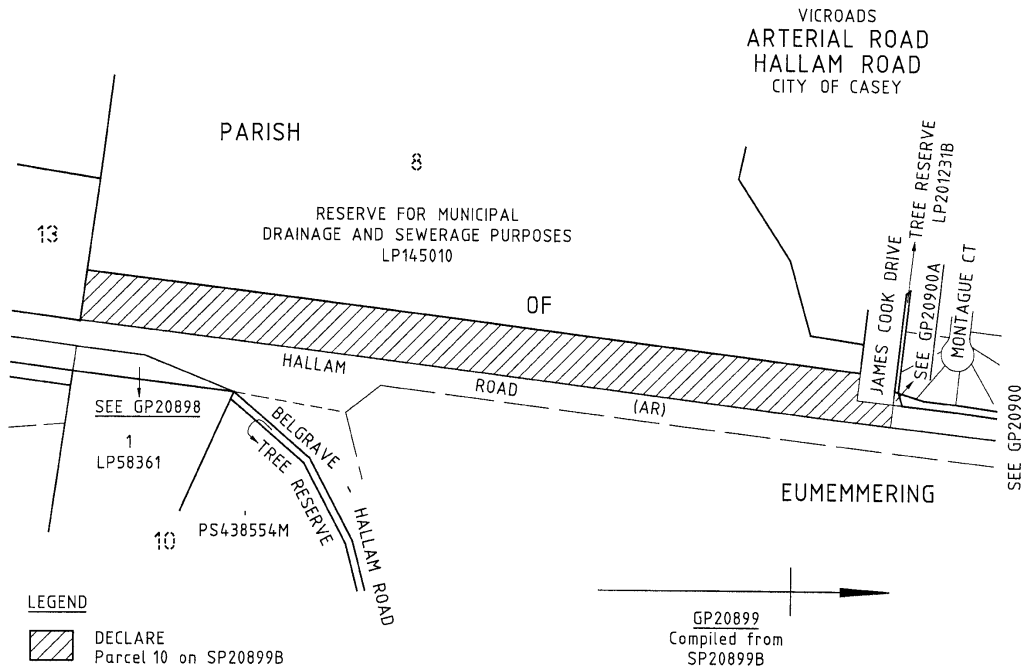

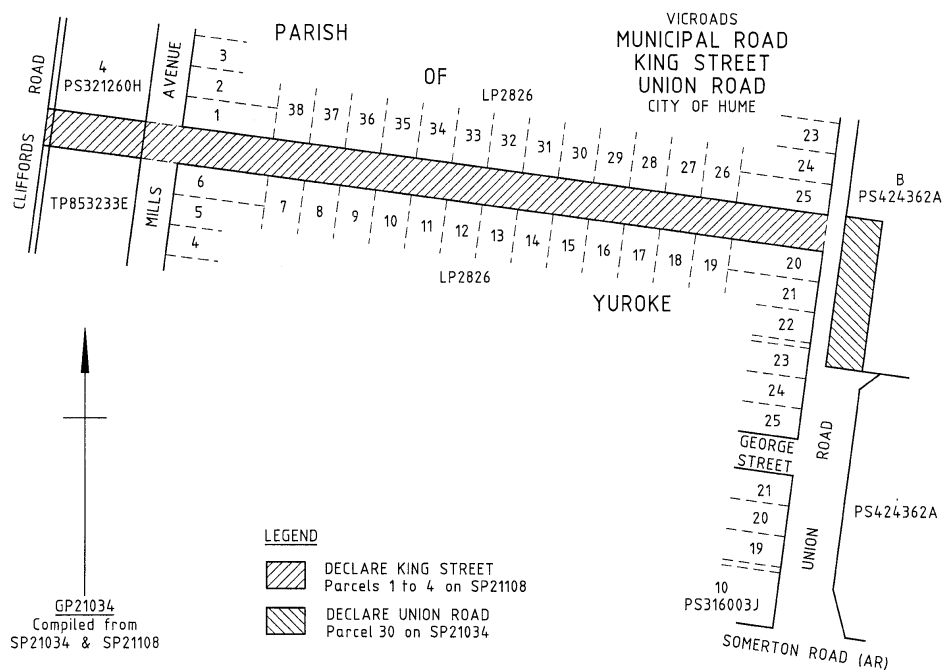
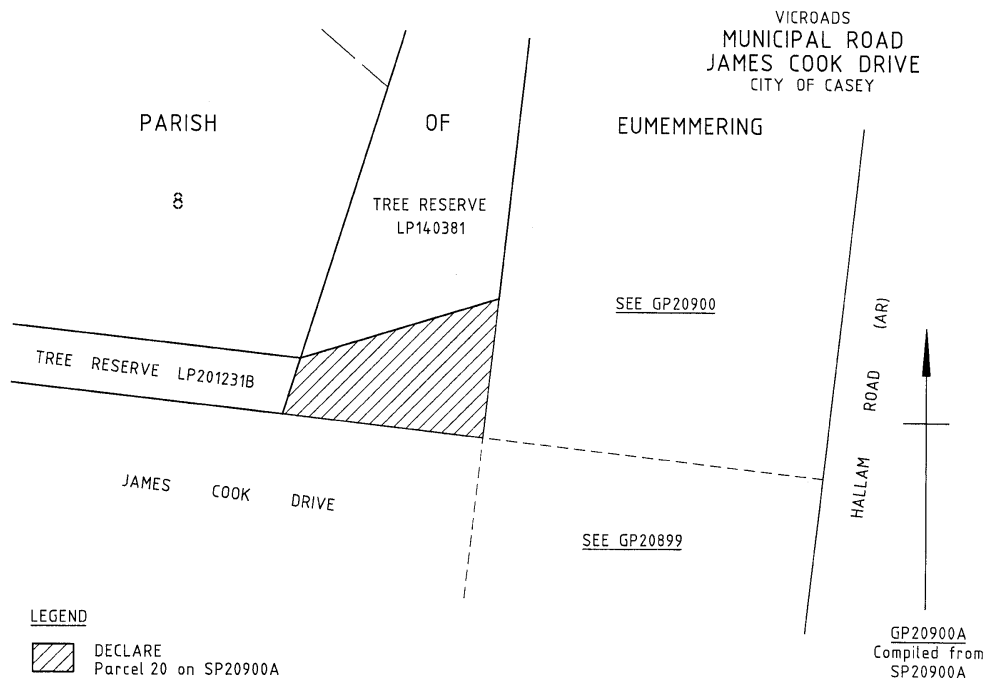
- a) That part of Melton Highway identified by hatching on the plan numbered GP19729 is discontinued as described in the legend in the said plan.
