



Upon reading the material submitted in support of the application, including the affidavit of Frank Hoff, the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 100 and 195 of the Act to enable the applicant to advertise for and employ a female for the position of Partner Support Worker.

In granting this exemption the Tribunal noted:

- the applicant conducts a men's behaviour change program.
- Part of the program involves contact with and support for women whose partners have been abusive.
- Whilst their partners undertake a behaviour change program conducted by the service, the service also works with these women.
- It is important that those who work with these women work with a female worker, in the circumstances of a history of abuse.

The Tribunal hereby grants an exemption to the applicant from the operation of Sections 13, 100 and 195 of the Act to enable the applicant to advertise for and employ a female for the position of Partner Support Worker.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 23 November 2009.


