
SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager, City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that:

- bathing and the operation of vessels, excluding authorised persons, competitors and vessels operated by Victoria Police, Parks Victoria, Lifesaving Victoria, Swimming Australia and other vessels authorised by the Chief Ranger Port Phillip, Parks Victoria (or delegate), are prohibited on the waters of Port Phillip within the area and times detailed below.
- (b) At the completion of activities on any of the times and dates detailed in Table A and as determined and announced by the Chief Ranger Port Phillip, Parks Victoria (or delegate), the waters will revert to the provisions of Schedule 1 contained in Notice No. 1 made under subsection 15(2) of the **Marine Act 1988**.
