VARIATION OF PIPELINE PERMIT 40

Section 12(4)

I, the Minister for Resources for the State of Victoria, under Section 12(4) of the **Pipelines Act 1967**, hereby vary the route of Pipeline Permit 40, owned by Multinet Gas (DB No. 1) Pty Ltd of Level 1, 33–39 Centreway, Mount Waverley 3149 and Multinet Gas (DB No. 2) Pty Ltd of Level 1, 33–39 Centreway, Mount Waverley 3149 by deleting Plan Number T340–2–1 A and T18–38D from the permit and adding Plan Numbers T340–2–1 B, T18–11–177 and T18–1–5 to the permit.
