Subordinate Legislation Act 1994 NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT

Transfer of Land (Fees) (Amendment) Regulations 2006

Notice is given that, in accordance with section 11 of the **Subordinate Legislation Act 1994**, a Regulatory Impact Statement (RIS) has been prepared in relation to the Transfer of Land (Fees) (Amendment) Regulations 2006.

The objective of the proposed Regulations is to amend the Transfer of Land (Fees) Regulations 2004 to increase certain mortgage fees and amounts payable to the Registrar under the **Transfer of Land Act 1958**.

The RIS discusses possible alternatives to the proposed Regulations and concludes that the proposed Regulations are the most effective means of meeting the stated objective.
