DECLARATION OF CLASS OF PERSONS UNDER SECTION 56ZZF OF THE COMMONWEALTH GAMES ARRANGEMENTS ACT 2001 IN RESPECT OF ACTIVITY UNDER S56ZR ALCOHOL

The Secretary to the Department for Victorian Communities (“the Secretary”), a body corporate created under section 25A of the **Commonwealth Games Arrangements Act 2001** (“the Act”) hereby declares that the classes of persons set out in Column 1 are authorised under section 56ZR for the activities listed in Column 2 in the area set out in Column 3, during a Games period.

The Commonwealth Games Village and the Bendigo Athletes Village.
Caterers, logistics operators and contracted service providers appointed by the Corporation, including their contractors, employees, agents and Corporation employees.	Possessing, delivering and/or removing alcohol from Games management areas in accordance with contractual and operational arrangements between a member of the class of persons and the Corporation.	Games management areas as reasonably required by the relevant contractual and operational arrangements between a member of the class of persons and the Corporation.
The general public	Possessing and/or removing alcohol in a container having an unbroken seal that has not been purchased from a licensed liquor provider located in a Games management area.	Games management areas except ticketed venues as defined in the Act.

DECLARATION OF CLASS OF PERSONS UNDER SECTION 56ZZF

 IN RESPECT OF ACTIVITY UNDER SECTION 56ZU PROHIBITED ITEMS

The Secretary to the Department for Victorian Communities ("the Secretary"), a body corporate created under section 25A of the **Commonwealth Games Arrangements Act 2001** ("the Act") hereby declares that the following classes of persons are authorised under section 56ZU to possess and bring into the Games management areas in Column 3, the prohibited items in Column 2.

Class of persons	Prohibited item authorised for possession or to be brought into Games management area	Area to which authorisation applies
Persons who are accredited by the Corporation to enter Games management areas	Prohibited items for the purposes of: (a) participating in a Commonwealth Games event, test event or training for the Commonwealth Games; (b) the management and conduct of Commonwealth Games events or associated events, activities or programs; (c) carrying out activities ancillary to or associated with the Commonwealth Games, Commonwealth Games events, or associated events, activities or programs; and (d) carrying out any other functions or powers under the Act.	All Games management areas as defined in the Act.

Class of persons	Prohibited item authorised for possession or to be brought into Games management area	Area to which authorisation applies
Members of the Victoria Police Force, Australian Federal Police, and the Australian Defence Force	Where prohibited items are reasonably necessary in order to carry out their respective duties.	All Games management areas as defined in the Act.
Essential services and emergency services	Where prohibited items are reasonably necessary to carry out their respective duties.	All Games management areas as defined in the Act.
The general public	Bicycles, scooters, roller skates, rollerblades and skateboards on the condition that the owner dismounts as directed by authorised officers and walks the bicycle, scooter or carries the roller skates, rollerblades or skateboard through the area.	Games management areas, except for restricted access areas, designated access areas, fields of play and ticketed venues as defined in the Act and in the case of skateboards, the skate park in Alexandra Gardens.
The general public	Skateboards	The skate park located in the Alexandra Gardens, being part of the Games management area, public domain for the Sidney Myer Music Bowl.
The general public	Dogs on the condition that section 14 of the Commonwealth Games Arrangements (Games Management Areas) Regulations 2006 is complied with and at the discretion of authorised officers.	All Games management areas as defined in the Act, except ticketed venues, restricted access areas, designated access areas and fields of play.

Terms and Conditions to which the authorisation is subject:

This authorisation is granted subject to any lawful directions given by any member of the Victoria Police Force or Australian Federal Police as well as any other terms and conditions for use of a prohibited item imposed by the Secretary or the Corporation, or each or any of them, as the case may be.
