# Wildlife (Control of Hunting) Notice No. 3/2006

#### 1. Title

This Notice may be cited as the Wildlife (Control of Hunting) Notice No.3/2006.

#### 2. Objective

The objective of this Notice is to prohibit the taking, destroying and hunting of the taxa of duck specified in Schedule 1 in the area of Victoria specified in Schedule 2, during the period commencing on Saturday 25 March 2006 and ending on Monday 12 June 2006 (both dates inclusive).

#### 3. Authorising provision

This notice is made under section 86 of the Wildlife Act 1975.

#### 4. Hunting of duck prohibited

The taking, destroying and hunting of the taxa of duck specified in Schedule 1 is prohibited in the area described in Schedule 2 during the period commencing on Saturday 25 March 2006 and ending on Monday 12 June 2006 (both dates inclusive).

# 5. Contravention of Notice

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.

#### 3. Authorising provision

This notice is made under section 86A of the Wildlife Act 1975.

# 4. Hunting of duck prohibited

The taking, destroying and hunting of the taxa of duck specified in Schedule 1 is prohibited in the area described in Schedule 2 during the period commencing on Saturday 18 March 2006 and ending on Friday 24 March 2006 (both dates inclusive).

#### 5. Contravention of Notice

A person must not contravene any part of this Notice.

Penalty: 25 penalty units.
