ROAD SAFETY (VEHICLES) REGULATIONS 1999

Class 2 Notice

Notice Concerning B – Double Routes

1. Purpose

To specify the areas, highways and routes that a B-double may travel on or in.

2. Authorising provision

This Notice is made under clause 11 of Schedule 2 to the Road Safety (Vehicles) Regulations 1999.

3. Commencement

This Notice comes into operation on the date of its publication in the Government Gazette.

4. Expiration

This Notice expires on 20 May 2006.

5. Definitions

In this Notice –

“**Regulations**” means the Road Safety (Vehicles) Regulations 1999.

6. Interpretation

(1) In this Notice, unless the contrary intention appears, expressions used have the same meaning as the **Transport Act 1983** and the Regulations.

(2) For the avoidance of doubt, it is declared that nothing in this Notice is intended to authorise the driving of a B-double in a manner or in a condition or place that is contrary to any law except as specifically provided in this Notice.

Example

The specification of a highway as a B-double route does not permit a B-double to be driven over any bridge in contravention of a posted mass or dimension limit in relation to that bridge.

7. Carrying Documents

A vehicle operating under the conditions of this Notice must have, in its driving compartment, for the purposes of regulation 821 of the Regulations, a copy of this Notice.

8. Declaration

By this Notice, I, Don Hogben, delegate of the Roads Corporation, specify that the following roads are routes on which B-doubles may be used:

CITY OF WYNDHAM

Doherty’s Road between Palmers Road and Fitzgerald Road;

Leakes Road between Palmers Road and Fitzgerald Road; and

Palmers Road between Boundary Road and Sayers Road.
