### WORKING WITH CHILDREN

### REGULATIONS 2006

#### Notice of Decision

I, Rob Hulls, Attorney-General, give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to recommend to the Governor in Council that the proposed Working with Children Regulations 2006 be made.

The proposed Working with Children Regulations 2006 prescribe the application form, the identifying information that must accompany the application form, application and replacement card fees and the form of the working with children check card. The proposed regulations will also provide that the Secretary to the Department of Justice must take into account certain findings from the Victorian Institute of Teaching when she is deciding whether or not to grant a working with children check. Finally, the regulations provide that the Secretary to the Department of Justice may delegate certain matters to Victoria Police.

The proposed Working with Children Regulations 2006 and Regulatory Impact Statement were advertised for public comment. Thirty-eight submissions were received.

Some amendments of a minor and technical nature have been made to the proposed Working with Children Regulations 2006 as published in the Regulatory Impact Statement.
