## Subordinate Legislation Act 1994

### NOTICE OF DECISION

#### Gambling Regulation (Commercial Raffle Organisers) Regulations 2006

I, John Pandazopoulos, Minister for Gaming give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to recommend to the Governor in Council that the proposed Gambling Regulation (Commercial Raffle Organisers) Regulations 2006 be made.

#### **Objective and effect of the proposed Regulations**

The objective of the proposed Regulations is to provide for—

- (a) fees for applications for, and applications for the renewal of, commercial raffle organiser's licences;
- (b) information to be included in notices relating to applications for commercial raffle organiser's licences;
- (c) conditions of a commercial raffle organiser's licence; and
- (d) the auditing of books, accounts and financial statements of the holders of commercial raffle organiser's licences.

#### **Receipt of Submissions**

A Regulatory Impact Statement (RIS) was prepared for the proposed Gambling Regulation (Commercial Raffle Organisers) Regulations 2006 and the public was invited to make written submissions on the proposed Gambling Regulation (Commercial Raffle Organisers) Regulations and RIS. Four submissions were received.

#### **Changes to the proposed Regulations**

There are two amendments to the proposed Gambling Regulation (Commercial Raffle Organisers) Regulations 2006 as follows:

- (i) regulation 3 has been amended so that the commencement date will be 1 July 2006; and
- (ii) regulation 9 has been amended to determine that the maximum fee to be paid to a licensee must be fair and reasonable.
