#### **1. Title**

These Regulations may be cited as the Melbourne Parks and Gardens (Joint Trustee Reserves) (Amendment) Regulations 2006.

#### **2. Objective**

The objective of these Regulations is to amend the Melbourne Parks and Gardens (Joint Trustee Reserves) Regulations 1994 to increase the daily charge per person to the Melbourne International Flower and Garden Show from a maximum of \$17.00 to \$20.00.

#### **3. Authorising provision**

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

#### **4. Commencement provision**

These Regulations come into operation on the day that they are published in the Government Gazette.

#### **5. Increase in maximum charge for entry to Carlton Gardens**

In Regulation 19(2) to the Melbourne Parks and Gardens (Joint Trustee Reserves) Regulations 1994, for "\$17.00" substitute "\$20.00".
