## Plant Health and Plant Products Act 1995

### ORDER DECLARING A RESTRICTED AREA NEAR BEECHWORTH FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Bob Cameron, Minister for Agriculture, under sections 20 and 22 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of Queensland Fruit Fly and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

**1 Objective**

The objective of this Order is to declare a restricted area for the control of Queensland Fruit Fly, at Mudgeegonga, near Beechworth, and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

**2 Authorising provisions**

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

**3 Definition**

In this Order-

“Act” means the **Plant Health and Plant Products Act 1995**; and

“Queensland fruit fly” means the exotic pest *Bactrocera tryoni* (Froggatt); and

“Queensland fruit fly host material” means any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Plant Health and Plant Product Regulations 1996.

**4 Restricted area for the control of Queensland fruit fly**

The restricted area for the control of Queensland Fruit Fly is declared to be the area described in Schedule 1.

**5 Prohibitions, restrictions and requirements**

- (1) This order does not apply to Queensland fruit fly host material grown within the restricted area if accompanied by—
  - (a) an assurance certificate issued by a person who is accredited by the Department of Primary Industries; or
  - (b) a plant health certificate issued by an authorised inspector – certifying that the Queensland fruit fly host material has been treated in a manner approved by the Manager Plant Standards.
- (2) The removal from the restricted area into any part of Victoria of any Queensland fruit fly host material is prohibited.
- (3) The owners and occupiers of land described in Schedule 2 must give access to such land at all times to an inspector, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspection, placing on such land any lures or traps, applying on such land any spray material or bait and performing any other actions in accordance with the Act which in the opinion of the inspector are necessary for the eradication or prevention or spread of the pest.
- (4) The owners and occupiers of land described in Schedule 2, on instruction from an inspector, must strip Queensland Fruit Fly host materials from plants, collect and

dispose of waste material, or treat the material in a manner approved by the Manager Plant Standards.

#### **Schedule 1**

The area of land bounded by a line commencing at the intersection of Andrew Lane and Dederang Road, then heading in a south-easterly direction along Dederang Road to the intersection of Dederang Road and Ben Valley Lane, then in a south-easterly direction along Ben Valley Lane to the intersection of Ben Valley Lane and Garvey Road, then in a straight line in a south-easterly direction to the intersection of Hellhole Creek Road and Cherry Tree Creek Road, then in a straight line in a southerly direction to the intersection of Yackandandah–Dederang Road and Kiewa Valley Highway, then in a south-easterly direction along Kiewa Valley Highway to the intersection of Kiewa Valley Highway and Rogers Lane, then in a straight line in a south-westerly direction to the intersection of Mt Jack Track and Running Creek Road, then in a westerly direction along Running Creek Road, which becomes Happy Valley Road, to the intersection of Happy Valley Road and Carrolls Road, then in a straight line in a north-westerly direction to the intersection of Morrisons Lane and Myrtleford–Yackandandah Road, then in a north easterly direction along Myrtleford–Yackandandah Road to the intersection of Myrtleford–Yackandandah Road and Kirks Lane, then in a northerly direction along Kirk Lane, which becomes Basin Creek Road, to the intersection of Basin Creek Road and Kirks Road, then in a straight line in a northerly direction to the intersection of Musgrove Road and Flagstaff Road, then in a north-easterly direction along Flagstaff Road, which becomes Six Mile Road, to the intersection of Six Mile Road and Myrtleford–Stanley Road, then in a northerly direction along Myrtleford–Stanley Road to the intersection of Myrtleford–Stanley Road and Stanley Road, then in a northerly direction along Stanley Road to the intersection of Stanley Road and Pioneer Road, then in a north-easterly direction along Pioneer Road, which becomes Hurdle Flat Road, to the intersection of Hurdle Flat Road and Chambeyron Road, then in an easterly direction along Chambeyron Road to the intersection of Chambeyron Road and Upper Nine Mile Road, then in a straight line in a north-easterly direction to the intersection of Yackandandah Road and Moyle Road, then in a north-easterly direction along Moyle Road to the intersection of Moyle Road and Kirby Flat Road, then in a north-easterly direction along Kirby Flat Road to the intersection of Kirby Flat Road and Back Creek Road, then in a south-easterly direction along Back Creek Road to the intersection of Back Creek Road and Andrews Lane, then in a north-easterly direction along Andrews Lane to the point of commencement.

The area of land in Victoria within a radius of one and a half kilometres of the property at 146.87626° East, 36.45944° South.

**1. Objective**

The objective of this Order is to declare a restricted area for the control of Queensland Fruit Fly, at Yackandandah, near Wodonga, and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

**2. Authorising provisions**

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

**3. Definition**

In this Order-

“**Act**” means the **Plant Health and Plant Products Act 1995**; and

“**Queensland fruit fly**” means the exotic pest *Bactrocera tryoni* (Froggatt); and

“**Queensland fruit fly host material**” means any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Plant Health and Plant Product Regulations 1996.

**4. Restricted area for the control of Queensland fruit fly**

The restricted area for the control of Queensland Fruit Fly is declared to be the area described in Schedule 1.

**5. Prohibitions, restrictions and requirements**

- (1) This order does not apply to Queensland fruit fly host material grown within the restricted area if accompanied by –
  - (a) an assurance certificate issued by a person who is accredited by the Department of Primary Industries; or
  - (b) a plant health certificate issued by an authorised inspector – certifying that the Queensland fruit fly host material has been treated in a manner approved by the Manager Plant Standards.
- (2) The removal from the restricted area into any part of Victoria of any Queensland fruit fly host material is prohibited.
- (3) The owners and occupiers of land described in Schedule 2 must give access to such land at all times to an inspector, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspection, placing on such land any lures or traps, applying on such land any spray material or bait and performing any other actions in accordance with the Act which in the opinion of the inspector are necessary for the eradication or prevention or spread of the pest.
- (4) The owners and occupiers of land described in Schedule 2, on instruction from an inspector, must strip Queensland Fruit Fly host materials from plants, collect and dispose of waste material, or treat the material in a manner approved by the Manager Plant Standard s.

**Schedule 1**

The area of land bounded by a line commencing at the intersection of Stanley Road and heading in a north-easterly direction along Stanley Road, which becomes Hodge Street to the intersection of Hodge Street and Albert Road, then in a north-westerly direction along Albert Road to the intersection of Albert Road and Ford Street, then in a north-easterly direction along Ford Street, which becomes Sydney Road, which becomes Beechworth–Wodonga Road, to the intersection of Beechworth–Wodonga Road and Beechworth–Chiltern Road, then in a north-westerly direction along Beechworth–Chiltern Road to the intersection of Beechworth–Chiltern Road and Reids Way, then in a north-easterly direction along Reids Way to the intersection of Reids Way and McGuiness Lane, then in a northerly direction in a straight line to the intersection of Deep Creek Road and Link Road, then in a north-easterly direction in a straight line to the intersection of Elligates Road and Baynes Gully Track, then in a north-easterly direction in a straight line to the intersection of McSweens Road and Indigo Creek Road, then in a south-easterly direction along Indigo Creek Road to the intersection of Indigo Creek Road and Hartigans Gap Road, then in an easterly direction along Hartigans Gap Road to the intersection of Hartigans Gap Road and Brewers Road, then in a straight line in a north-easterly direction to the intersection of Phillips Road and Castle Creek Road, then in an easterly direction along Castle Creek Road to the intersection of Castle Creek Road and Drapers Road, then in south-easterly direction along Drapers Road to the intersection of Drapers Road and Beechworth–Wodonga Road, then in a southerly direction along Beechworth–Wodonga Road to the intersection of Beechworth–Wodonga Road and Boyes Road, then in a north-easterly direction along Boyes Road to the intersection of Boyes Road and Edneys Lane, then in a south-easterly direction in a straight line to the intersection of Yackandandah–Wodonga Road and Lindsay Road, then in a south easterly, then easterly direction along Lindsay Road to the intersection of Lindsay Road and Turvey Lane, then in a southerly direction in a straight line to the intersection of Powerline Road and Simpson Road, then in a south-easterly direction along Simpson Road to the intersection of Simpson Road and Gap Flat Road, then in a south-westerly direction along Gap Flat Road to the intersection of Gap Flat Road and Condons Track, then in a south-westerly direction in a straight line to the intersection of Yackandandah–Dederang Road and Tunnel Gap Road, then in a westerly direction in a straight line to the intersection of Cook Lane and Myrtleford–Stanley Road, then in a northerly direction along Myrtleford–Stanley Road to the intersection of Myrtleford–Stanley Road and Stanley Road, then in a north-westerly direction along Stanley Road to the point of commencement.

**Schedule 2**

The area of land in Victoria within a radius of one and a half kilometres of the property at 146.83964° East, 36.31168° South.
